The letter of the incumbent foregoing promotion must be pasted in his/her Service Book with necessary entries therein and a copy of the same may be sent to this office for verification. In such case, the provision of the rule under F.D. No. 6042 – F dated 07.11.2019 and this office order no. 12-W/2017-18 dated 08.08.2017 shall apply.
