With reference to your memorandum bearing no. 1692/V/O'Cell /PER(NAR)-494/2022 dated: 23.11.2022, I am directed to state that the allegation is **baseless and not tenable** as per the report submitted by the Three-member Enquiry Committee constituted to enquire into the allegation after **physical inspection of the site** during the course of enquiry on 26.9.2022. Though the last para of the letter of the State Vigilance Commission, W.B. has refrained this department from sending the said enquiry report to the Commission as nothing adverse emerges, a copy of the aforesaid inquiry report bearing Memo. No. 1441 dated: 27.09.2022 which has been submitted by the Chief Engineer (North), vide his memo. No. 07-CON dated: 28.2022, is sent herewith to affirm about the action taken already by the department in respect of the earlier memo. No. 1189/V/O' Cell/Per (NAR)-345/2022 dated: 02.08.2022 in the same matter.
