Agenda: Proposal for recommendation of 06 (six) new schemes (02 schemes costing above Rs 1.50 crore) for inclusion under **Core SDS** for FY of **2022-23**.

One scheme (under sl 1) for construction of RCC Sluice near Udaypur khal at Adarsha Nagar, Ward No. 35, Kamarhati Municipality, P.S.-Belgharia, Dist-North 24 PGS under Executive Engineer, Urban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I&WDte. in their 54th Meeting held on 08.12.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work as well as some attachment within scheme booklet.

It has been resolved that for this instant scheme separate tenders are to be invited by the "Civil Wing" as well as "Mechanical Wing" of Irrigation & Waterways Directorate having territorial jurisdiction, based on individual technically sanctioned amount within the provision of this scheme, for the interest of work.

- 2. One scheme (under sl 2) to overcome of drainage congestion of Food & Poly Parks by improvement of Sandhipur khal in P.S. Sankrail, Dist- Howrah under Executive Engineer-I, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I&WDte. in their 51st Meeting held on 14.10.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work as well as some attachment within scheme booklet.
- **3.** One scheme (under sl 3) for construction of Raiganj town protection extension embankment in P.S.Raiganj, Dist- Uttar Dinajpur under Executive Engineer, North Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I&WDte. in their 54th Meeting held on 08.12.2022.
