Agenda: Proposal for recommendation of 22 (twenty two) new schemes and 02 (two) additional scheme (all schemes costing below Rs. 1.50 costs) for inclusion under Core State Development Schemes(Voted) budget of Irrigation & Waterways Department during the current FY of 2022-23. 1.One scheme (under sl 1) related to construction of one composite bridge over BB1 khal near Jora Mandir within P.S. New Town, Dist : North 24 Parganas under Metropolitan Drainage Division-I initially technically recommended by the Directorate Level Technical Committee in their 37th Meeting held on 24.05.2022. The scheme has been placed in the present DSC meeting and recommended.

2.One scheme (under sl 2) related to construction of two Sluice structures at Banstola and Bowthakurani in P.S. Hingalganj, Sandeshkhali, Dist: North 24 Parganas under Basirhat Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 40th Meeting held on 21.06.2022. The scheme has been placed in the present DSC meeting and recommended with some modifications in name of work, attachment in the scheme booklet as well as some minor changes in estimate of work.

3.One scheme (under sl 3,4,5) related to construction of three Sluice structures at Shyamnagar, Nolgora in P.S. : Kultali and at Kankandighi in P.S. : Raidighi, Dist : South 24 Parganas under EE-II, Joynagar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 42th Meeting held on 07,07,2022. These 03 schemes have been placed in the present DSC meeting and recommended with some modifications in name of work, attachment in the scheme booklets.

4.One scheme (under sl 6) related to construction of one single vent RCC Box culvert at Bilkumari Biler Math within P.S.: Nakashipara , Dist ; Nadia under Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 38th Meeting held on 30.05.2022. This 01 scheme has been placed in the present DSC meeting and recommended with some modifications in name of work , attachment in the scheme booklets .

5. One scheme (under sl 7) related to anti-erosion work to left bank of river Bhagirathi at Santipur Water Treatment Plan, PS: Santipur, Dist-Nadia under Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 37th Meeting held on 24.05.2022. This 01 scheme has been placed in the present DSC meeting and recommended with some modification in attachment in the scheme booklet.

6.One scheme (under sl 8) related to construction of eleven no. Sluice structures within P.S.: Jamalpur, Pursura, Tarakeswar, Dist : Purba Bardhaman and Hooghly under EE-I, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 39th Meeting held on 08.06.2022. This 01 scheme has been placed in the present DSC meeting and recommended with some modifications in name of work, attachment in the scheme booklets as well as some minor changes in scope of work.

7. One scheme (under sl 9) related to SITC of transformer at 2nd additional Cowbhaga Pumping Station in P.S ; Anandapur, Dist ; 24 pgs (South) under Metropolitan Drainage Mechanical Division initially technically recommended by the Directorate Level Technical Committee in their 37th Meeting held on 24.05.2022. This 01 scheme has been placed in the present DSC meeting and recommended with some modifications in name of work, attachment in the scheme booklet.

8. One scheme related to taking post work survey of re-excavation of drainage channels within KMC and surrounding municipal areas under Investigation & Planning Division (South) initially technically recommended by the Directorate Level Technical Committee in their 38th Meeting held on 30.05.2022. The scheme has been placed and resolved that the scheme is dropped from this DSC scheme list considering nature of work. The expenditure to be involved against this scheme is to be charged out of work contingency of various ongoing drainage improvement schemes within KMC and surrounding areas. The Chief Engineer (D&R) may approach to the Chief Engineer (South) for arrangement of this fund from such ongoing work contingency head .

9 Finally, 09 no. schemes (as per Annexure -I) has been cleated by the DSC for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2022-23. It has been directed to submit the soft copy (PDF version) of this scheme as per enclosed list duly technically sanctioned by competent authority.

10.All remaining 14 no. schemes (as per Annexure -II) are eligible for recommendation but kept pending for now regarding processing of Administrative Approval.
