The place of posting of the newly promoted Zilladars is to be decided by the concerned Revenue Officers as per the scarcity of manpower in the offices under their jurisdiction.

The Tahasildars, under his control, may duly be released immediately so that they may join their respective assignments in the post of Zilladar forthwith and this office may be informed with a copy of release order as well as joining letter in the post of Zilladar positively.

If any Tahasildar denies to accept the promotion, this office must be informed in writing instantly. The letter of the incumbent foregoing promotion must be pasted in his/her Service Book with necessary entries therein and a copy of the same may be sent to this office for verification. In such case, the provision of the rule under F.D. No. 6042 – F dated 07.11.2019 and this office order no. 12-W/2017-18 dated 08.08.2017 shall apply.
