## ORDER

**Sk Saddam Azam** was appointed to the post of Lower Division Assistant in Irrigation & Waterways Department in the pre-revised pay structure of Pay Band-2 (Rs.5,400-25,200) with Grade Pay of Rs.2,600/- [corresponding to Level-6 (Rs.22,700-58,500/-) of the Pay Matrix under WBS (ROPA) Rules, 2019] under Order No. 26-PAR(CCW)/Estt. dated 13.02.2019 of the Personnel & Administrative Reforms Department. He joined the post of L.D.A. in Irrigation & Waterways Department on 20.03.2019 (F.N.) vide I & W Department's Memo No. 825-IE dated 27.03.2019.

Before joining the post of L.D.A. in I & W Department, Sk Saddam Azam had rendered service as Constable of Kolkata Police in Pay Band-2 (Rs. 5,400-25,200/-) with Grade Pay of Rs. 2,600/- for the period from **24.08.2017 to 19.03.2019.** In his previous service in Kolkata Police, he was allowed one advance increment at entry level and her pay was fixed at Rs. 9,110/- (Pay in Pay Band Rs. 6510/- + GP Rs. 2600/-) in PB-2 (Rs.5400-25200) with Grade Pay of Rs. 2600/- w.e.f 12.07.2018. His last pay in previous service was Rs. 9,110/- (Pay in Pay Band Rs. 6510/- + GP Rs. 2600/-).

Now, in terms of Rule 42(2) (a) (ii) of WBSR Pt.-I, after protecting his one increment on 01.07.2018 in his previous service, the pay of Sk Saddam Azam in the post of L.D.A. in I & W Department is hereby fixed at Rs. 9,110/- (Pay in Pay Band Rs. 6510/- + GP Rs. 2600/-) o n 20.03.2019, with subsequent increment on 01.07.2019, to be drawn till 31.12.2019 under WBS (ROPA) Rules, 2009. Accordingly, his pay is fixed at Rs. 23,400/- w.e.f. 20.03.2019 on notional basis with actual effect from 01.01.2020 in terms of Rule 8 of WBS (ROPA) Rules, 2019. This has the approval of the Finance Department (Group-P1) vide their U.O. No. Group P1/2022-2023/0385 Date: 03.01.2023.

Thus, the pay of Sk Saddam Azam in the post of Lower Division assistant in Irrigation & Waterways Department is hereby fixed at **Rs. 25,500/- w.e.f. 01.07.2022** in Cell- 5 of Level-6 as per WBS (ROPA) Rules, 2019, after allowing two annual increments subsequently on 01.07.2021 and 01.07.2022.

His next increment will fall due on 01.07.2023 if he is found to be otherwise eligible. Overdrawn amount due to erroneous Pay fixation, if any, will be recovered from the pay & allowances of Sk Saddam Azam in due course.

This Order issues in cancellation with this Department's earlier Order No. 777-IW dated 20.03.2023.
