ORDER

Sri Akshay Kumar Mahata, Junior Engineer (Civil), posted at Kangsabati Canals Division No.-V in Irrigation & Waterways Department, was appointed as Nirman Sahayak in Bhuladeva Gram Panchayat under Binpur-II Development Block vide their order No. 186/1(436)/SA/07 dated 29.06.2007 on **11.07.2007 (FN)** in the Pay Scale of Rs. 9,000-40,500/ with Grade Pay of Rs. 4,400/- as per ROPA 2009.

Having been selected in the Sub-Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Order No. 1962(68)-CIE dated 27.06.2011 of the Director of Personnel & Ex-Officio Chief Engineer, I & W Dte, Sri Akshay Kumar Mahata joined the post of Sub-Assistant Engineer (Civil) (now renamed as Junior Engineer) in Irrigation & Waterways Department on **21.07.2011 (FN)** in the Pay Scale of Rs. 9,000-40,500 /- with Grade Pay of Rs. 4,400/- as per ROPA 2009, after being released from the post of Nirman Sahayak on **20.07.2011 (AN)** vide Order No. 945(6) dated 20.07.2011 of the Block Development Officer, Binpur-II Development Block.

Now, the Governor has been pleased to accord approval to count the previous service from **11.07.2007 (FN) to 20.07.2011 (AN)**, as rendered by Sri Akshay Kumar Mahata, Junior Engineer (Civil), Kangsabati Canals Division No.- V, Irrigation & Waterways Directorate, in his erstwhile appointment to the post of Nirman Sahayak, in Bhuladeva Gram Panchayat under Binpur-II Development Block under Panchayat & Rural Development Department, Govt. of W.B., in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) dated 27.05.2019 read with Rule 33(2) of D.C.R.B. Rules'1971, for the purpose of pension and leave only.

However, the previous service of Sri Akshay Kumar Mahata cannot be counted for seniority and MCAS'2001 benefit, for his present service, in West Bengal Engineering Services.
