ORDER

The Central Flood Control Cell (CFCR), situated at the ground floor of Jalasampad Bhavan, Western Block, DF Block, Sector-I, Salt Lake – 700091, operates 24 x 7 from 1st June to till 31st October every year, will be shifted to 1st floor of State Data Centre (SDC), built under NHP and situated at Sech Abasan, FF Block, Sector-III, Salt Lake – 700106 from 1st June this year. The Director, Advance Planning, Project Evaluation & Monitoring Cell, Irrigation & Waterways Directorate, being the Nodal Officer of the Central Flood Control Cell (CFCR), shall co-ordinate with the following Divisions for shifting of equipments and furniture to the new location to make the CFCR functioning by 1st June, 2023.

2. The Executive Engineer, Metropolitan Drainage Division No.I, Irrigation & Waterways Directorate, shall make arrangements for shifting and installing of all existing furniture, existing water purifier, existing Television from CFCR, Jalasampad Bhavan to SDC, Sech Abasan. He shall ensure regular housekeeping of the premises including cleaning of toilets regularly to keep the environment hygienic.

3. The Executive Engineer-I, Investigation & Planning Division (South), Irrigation & Waterways Directorate, shall make arrangements for shifting and installing of all 4 Desktop Computers along with all accessories including printer, fax, photocopier machine from CFCR, Jalasampad Bhavan to SDC, Sech Abasan. He shall also make arrangement for regular maintenance of all IT peripherals of the CFCR at the new location.

4. The Executive Engineer, Metropolitan Electrical Division, Irrigation & Waterways Directorate, shall make arrangements for shifting and installing of Video Wall (6 panels) from CFCR, Jalasampad Bhavan to SDC, Sech Abasan. He shall make arrangements for any

additional cabling and plug points at the new location, if required, to install all electronic gadgets. He shall also co-ordinate with BSNL for shifting and installing of existing telephone connections to new location.

5. The Executive Engineer-I, Lower Damodar Irrigation Division, Irrigation & Waterways Directorate, shall apply to BSNL, Bidhannagar for shifting and installing of Telephone No.033-23340117 from CFR, Jalasampad Bhavan to SDC, Sech Abasan. He shall also make arrangement for installation of Toll Free no from BSNL in co-ordination with the Executive Engineer, Metropolitan Electrical Division, Irrigation & Waterways Directorate.

6. The Chief Engineer (South), Irrigation & Waterways Directorate, shall apply to BSNL, Bidhannagar for shifting and installing of Telephone No.033-23218341 from CFR, Jalasampad Bhavan to SDC, Sech Abasan. The Executive Engineer, Metropolitan Electrical Division, Irrigation & Waterways Directorate, will co-ordinate with him for filling of application to BSNL.






