Agenda: Proposal for recommendation of 17 (seventeen) new schemes (Twelve schemes costing below Rs 1.50 crore) for inclusion under **Core SDS** for FY of **2023-24**

Secretary took the chair. The following were discussed ;

1. One scheme (under sl 1) for strengthening of one embankment along ring bank of river Hooghly at Purba -Basudevpur , in Block- Shyampur-I , Dist- Howrah under Executive Engineer, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 60th Meeting held on 09.02.2023 and in the 307th Meeting of Departmental Technical Committee of Chief Engineers held on 17.02.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

2. One scheme (under sl 2) for re-excavation of Pana Branch khal of Balarampur Main khai in PS- Ramnagar, Block- Diamond Harbour-II, Dist- 24 Parganas (South) under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 58th Meeting held on 16.01.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

3. One scheme (under sl 3) for construction of RCC Foot bridge over Kantakhali khal at Gobindapur-Kalicharanpur ,Block-Bishnupur-II, Dist- 24 Parganas (South) under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 63th Meeting held on 28.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

4. One scheme (under sl 4) for river bank protection work along left bank of river Hooghly near 83 bus-stand at Jafarpur , Block-Falta , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 63th Meeting held on 28.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

5. One scheme (under sl 5) for de-siltation of Sangrampur-Kuleswar-Kajipara khal , within GP-Dearak, Block- Diamond Harbour-I , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the

Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

6. One scheme (under sl 6) for de-siltation of Madhubati-Naoga khal , within GP-Masat, Block- Diamond Harbour-I , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

7. One scheme (under sl 7) for de-siltation of Falta –Saharhat khal , within GP-Falta, Block- Falta , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 63th Meeting held on 28.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

8. One scheme (under sl 8) for de-siltation of khal from Sarisha Ashram more to Cheora via Narayantala F.P. School within GP- Sarisha, Block- Diamond Harbour-II , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

9. One scheme (under sl 9) for de-siltation of Banariapur khal within Block- Budge-Budge ,Dist- 24 Parganas (South) under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

10. One scheme (under sl 10) for construction of one double lane RCC bridge at Bamunmura over river Suti within Barasat Municipality , PS-Barasat, ,Dist- 24 Parganas (North) under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 42th Meeting held on 07.07.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

11. One scheme (under sl 11) for construction of one single lane RCC bridge at Mominpur over Nonagong within Ashokenagar-Kalyangarh Municipality ,PS-B-Ashokenagar, ,Dist- 24 Parganas (North) under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

12. One scheme (under sl 12) for river bank protection work along left bank of river Hooghly at Rajarampur within Block-Falta , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 63th Meeting held on 28.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

13. One scheme (under sl 13) for river bank protection work along left bank of river Hooghly at Rajarampur within Block-Falta , Dist- 24 Parganas (South) under Executive Engineer-II ,Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 63th Meeting held on 28.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and in attachment within scheme booklet.

14.One scheme (under sl 14) for de-siltation of branch of Koirapukur khal within Block-Barrackpore-II , P.S.-Titagarh , Dist- 24 Parganas (North) under Executive Engineer, ,Urban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 64th Meeting held on 06.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

15. One scheme (under sl 15) for de-siltation of Balarampur khal within Blocks-Falta, Diamond Harbour-II, Dist- 24 Parganas (South) under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 62th Meeting held on 16.03.2023 and in the 308th Meeting of Departmental Technical Committee of Chief Engineers held on 20.03.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in attachment within scheme booklet.

16. One scheme (under sl 16) for construction of one bridge cum regulator structure over Alampur khal at Bagpara, PS-Nodakhali, Block-Budge-Budge-II, Dist- 24 Parganas (South) under Executive Engineer, Suburban Drainage Division and Metropolitan Drainage Mechanical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 65th Meeting held on 12.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and in attachment within scheme booklet.

It has been resolved that for this instant scheme separate tenders are to be invited by the "Civil Wing" as well as "Mechanical Wing" of Irrigation & Waterways Directorate having territorial jurisdiction, based on individual technically sanctioned amount within the provision of this scheme, for the interest of work.

17. One scheme (under sl 17) for replacement of flap shutters, draw shutters including painting of gates of 30 vent sluice in Block and PS –Diamond Harbour, Dist- 24 Parganas (South) under Executive Engineer, Metropolitan Drainage Mechanical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 64th Meeting held on 06.04.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and in attachment within scheme booklet.

18. Finally, 17 no. new schemes as per Annexure have been cleared by the DSC for inclusion under **Core SDS** during the current **FY 2023-2024**.

19. With regard to the items related to fencing and hedging , as considered in some schemes , it has been resolved in this meeting that no excess of quantity over BoQ quantity against those items will be entertained during execution as well as any savings of those items cannot be used for execution of excess quantity(s) against other items.

20. It has been directed to submit the soft copy (PDF version) of this scheme as per enclosed list duly technically sanctioned by the competent authority

21. As e-NITs have already been floated against some schemes in terms of Memo No. 54-IRW-IV-01/16 , dated 24.03.2023 of this Department , it has been advised by the Financial Advisor of this Department to attach pdf copy of BoQ at end part of those schemes during final submission.

22. Regarding invitation of tender before obtaining Administrative Approval & Financial Sanction of appropriate authority , it has been discussed that there is no express provision in WBFR regarding timing of invitation of tender i.e. after obtaining AA&FS or before obtaining AA& FS. As there is no clear provision regarding the facts, the Financial Advisor of this Department advised that valuable opinion of Finance Department may be initiated. However point-4 of the FD Memo No. 2131-F(Y) dt.05.04.2019 may be referred in this regard.
