**ORDER**

**Shri Santanu Mandal** was appointed to the post of Lower Division Assistant in Irrigation & Waterways Department in the revised pay structure of Pay Level-6 (Rs.22,700-58,500) with pre-revised Grade Pay of Rs.2,600/- in Pay Matrix under WBS (ROPA) Rules, 2019 under Order No. 19-PAR(CCW)/Estt. dated 21.01.2022 of the Personnel & Administrative Reforms Department. He joined the post of L.D.A. in Irrigation & Waterways Department on 09.02.2022 (F.N.) vide I & W Department's Memo No. 470-IE dated 17.02.2022.

Before joining the post of L.D.A. in I & W Department, Shri Santanu Mandal had rendered service as Krishi Prayukti Sahayak (KPS) at the O/o the Assistant Director of Agriculture, Ratua-II Block, under Chanchal Sub-Division, Malda from 29.04.2019 (F.N.) to 08.02.2022 (A.N.) in pre-revised scale of Pay Band-2 (Rs. 5,400-25,200/-) with Grade Pay of Rs. 2,900/- with minimum Basic pay at Rs. 9,600/- under ROPA'09. [Revised pay Level-7 in the pay matrix of ROPA'2019]. His last pay as on 08.02.2022 (A.N.) in his previous service was **Rs. 26,200/-** in Pay Level-7 of the Pay Matrix as per WBS (ROPA) Rules, 2019 (after allowing two annual increments on 01.07.2020 and 01.07.2021 respectively).

Now, in terms of Rule 8 of WBS (ROPA) Rules, 2019, the pay of Shri Santanu Mandal in the post of L.D.A. in I & W Department is hereby fixed at **Rs. 26,200/- (Rs. 25,500/- being Cell 5 in Level 6 plus Rs. 700/- personal pay which is to be absorbed in next increment)** w.e.f. 09.02.2022. This has the approval of the Finance Department (Group-P1) vide their U.O. No. **Group P1/2023-2024/0084 Dated 29.05.2023.**

His next increment will fall due on 01.07.2023 and his pay will be fixed at **Rs. 26,300/- (Level-6, Cell- 6)**, if he is found to be otherwise eligible. Overdrawn amount due to erroneous Pay fixation, if any, will be recovered from the pay & allowances of Shri Santanu Mandal in due course.
