



I am directed to inform that in terms of Rule 8 of West Bengal Services (Recruitment to clerical cadre) Rules, 2019 as notified under the Finance Department notification no.662-F(P2), dated 24/01/2019 read with F.D. notification no. 9045-F, dated the 26th July, 1983 the next Half-yearly Departmental Examination in Bengali for probationary L. D. Assistants recruited to the clerical services of the West Bengal Secretariat and certain other offices of the Govt. of West Bengal and whose mother tongue is not Bengali, will be held on the 28th June, 2023 in the **Examination Halls** of the Commission at 161A, S. The standard of examination shall not be higher than that of class - VIII of the Board of Secondary Education, West Bengal.
