ORDER

Sri Sandip Das, Executive Engineer, Mayurakshi Head Quarters Division, Irrigation & Waterways Directorate (Erstwhile posted in Sundarban Delta Project, River Research Institute, I & W Dte.) was appointed as an employee of Public Works (Roads) Directorate in the capacity of Sub Assistant Engineer (SAE), (presently designated as Junior Engineer) on **25/09/2000 (FN)** in the pay scale of Rs. 4500/- to 9700/- vide their order no. **1958-R/E Dated-20/09/2000** on recommendation of Public Service Commission, West Bengal.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of the Order No. 110 Dated-30/12/2005 of this Department, Sri Das joined the post of Assistant Engineer (Civil) in Irrigation and Waterways Directorate under Irrigation and Waterways Department on **17-02-2006 (FN) in the Pay Scale of Rs. 8,000/- to 13,500/-** as per ROPA 1998, after being released from the post of Sub-Assistant Engineer on **16/02/2006** vide Public Works Department's Order No. **176/P-432 dated 16/02/2006**.

Now, the Governor has been pleased to accord approval **to count the previous service from 25/09/2000 (FN) to 16/02/2006 (AN)** as rendered by Sri Sandip Das, Executive Engineer, Sundarban Delta Project, River Research Institute, Irrigation & Waterways Directorate, in his erstwhile appointment to the post of Sub-Assistant Engineer, under Public Works (Roads) Directorate, Govt. of West Bengal, in terms of Finance (Pension) Department's No. **249-F (Pen) 27/05/2019** and No. **10253-F dated the 29/09/1988** read with Rule **33(2) of D.C.R.B Rules' 1971**, for pensionary benefit only.

However, the previous service of Sri Sandip Das cannot be counted for seniority and MCAS'2001 benefit, for his present service, in West Bengal engineering Services.
