**NOTIFICATION**

WHEREAS, Directorate of Horticulture under the administrative control of the Department of Food Processing Industries & Horticulture began running independently with a set of Group-A officers being transferred from the Agriculture Department, Government of West Bengal to the newly created Department of Food Processing Industries & Horticulture in the year 1997. Thereafter the Department of Food Processing Industries & Horticulture in consultation with Finance Department restructured the entire set up of Horticulture Directorate for smooth functioning in the year 2010.

WHEREAS, the existing system of designating the officer in charge of the District Horticulture Office either as Assistant Director of Horticulture or Deputy Director of Horticulture, is causing administrative difficulties.

AND WHEREAS, a proposal was sent to the Finance Department for their concurrence for change of nomenclature of the officer in charge of the District Horticulture Office as District Horticulture Officer (DHO) irrespective of their rank in the Directorate of Horticulture and the Finance Department has agreed to the proposal vide their U.O. No. Group P2/2022-2023/0766 dated-20/01/2023.

AND WHEREAS, the Cabinet in its meeting on 06/03/2023 accorded approval to the said proposal of Department of Food Processing Industries & Horticulture for change of nomenclature of DHOs in 18 (eighteen) districts irrespective of their rank, Pay Level and total sanctioned strength in a district in the Directorate of Horticulture under the administrative control of Department of Food Processing Industries and Horticulture vide Cabinet Sectt. U/O No. CAB(D) - 561 dated 09/03/2023.

NOW THEREFORE, the Governor has been pleased to revise the nomenclature of DHOs in 18 (eighteen) districts irrespective of their rank, Pay Level and total sanctioned strength in a district as follows with immediate effect :-
