Agenda: Proposal for recommendation of 07 (seven) new schemes (04 schemes costing below Rs 1.50 crore) for inclusion under **Core SDS** for FY of **2023-24**

Secretary took the chair. The following were discussed ;

1. One scheme (under sl 1) for improvement of road along right bank of lower Bagjola khal within ward no. 22 of Bidhannagar Municipal Corporation in PS- Baguiati, and New Town ,Dist-North 24 Parganas under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 73th Meeting held on 08.06.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
2. One scheme (under sl 2) for river bank protection work on left bank of river Ganga adjacent to confluence of river Koshi in Blocks –Ratua-I ,Manikchak , Dist- Malda under Executive Engineer, Malda Irrigation Division initially technically recommended by Directorate Level Technical Committee of I.&W.Dte. in 66th Meeting held on 20.04.23 followed by Departmental Technical Committee of Chief Engineers in their 312th Meeting on 19.05.23. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
3. One scheme (under sl 3) for improvement of left Ex-zamindari embankment of river Hinglow in Block –Khayrasole ,Dist-Birbhum under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by Directorate Level Technical Committee of I.&W.Dte. in their 65th Meeting held on 12.04.2023 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
4. One scheme (under sl 4) for protection work of left embankment of river Ajoy at Ratanpur near PHE Pump House in Block –Khayrasole , Dist-Birbhum under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 65th Meeting held on 12.04.2023 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
5. One scheme (under sl 5) for protection to eroded bank line along left Ex-zamindari embankment of river Ajoy in Block –Bolpur ,Dist-Birbhum under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 65th Meeting held on 12.04.2023 . This

scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

6. One scheme (under sl 6) for river bank protection work on right bank of river Torsa at Maltiguri in Block-Coochbehar-II, Dist-Coochbehar under Executive Engineer, Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 71th Meeting held on 25.05.2023 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

7. One scheme (under sl 7) for river bank protection work on right bank of river Hooghly at Ramkrishna Math & Mission in PS-Belur, Dist-Howrah under Executive Engineer, Lower Damodar Construction Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 73th Meeting held on 08.06.2023 .This scheme has been placed in the present DSC meeting and recommended with some attachment within scheme booklet. .

8. One scheme for construction of two vent sluice at left bank of river Ganga in Raipur , Block-Budge Budge-II,Dist-South 24 Parganas under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 71th Meeting held on 25.05.23. This scheme has been placed in the present DSC meeting and it has been resolved that the scheme is to be resubmitted in next DSC meeting after checking by Central Design Office for additional scope of work as considered beyond provision in present drawing of CDO, furnishing requisite documents against required private land for implementation of this scheme .

9. Finally, 07 no. new schemes as per Annexure have been cleared by the DSC for inclusion under **Core SDS** during the current **FY 2023-2024**.


