**ORDER**

Sri Baru Das, Junior Engineer (Civil), posted at Mayurakshi South Canals Division in Irrigation & Waterways Department, was appointed as Nirman Sahayak in Rajnagar Panchayat Samiti under Birbhum District vide Panchayat & Rural Development Department's order No. 1107/Raj dated 21.09.2005 on **21.09.2005 (FN)** in the Pay Scale of Rs. 9,000-40,500/ with Grade Pay of Rs. 4,400/- as per WBS (ROPA) Rules, 2009.

Later, his service was regularized vide Order No. 1905(26)/P dated 08.02.2006 of the Executive Officer, Birbhum Zilla Parishad on **03.01.2006**.

Then, having been selected in the Sub-Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Order No. 1962(68)-CIE dated 27.06.2011 of the Director of Personnel & Ex-Officio Chief Engineer, I & W Dte, Sri Baru Das joined the post of Sub-Assistant Engineer (Civil) (now renamed as Junior Engineer) in Irrigation & Waterways Department on **26.09.2011 (AN)** in the Pay Scale of Rs. 9,000-40,500 /- with Grade Pay of Rs. 4,400/- as per WBS (ROPA) Rules, 2009, after being released from the post of Nirman Sahayak on **26.09.2011 (FN)** vide Order No. 252/1/8/2011 dated 26.09.2011 of the Block Development Officer, Khoyrasole Development Block.

Now, the Governor has been pleased to accord approval to count the previous service from **03.01.2006 (FN) to 26.09.2011 (FN)**, as rendered by Sri Baru Das, Junior Engineer (Civil), Mayurakshi South Canals Division, Irrigation & Waterways Directorate, in his erstwhile appointment to the post of Nirman Sahayak, in Rajnagar Panchayat Samiti in Birbhum District under Panchayat & Rural Development Department, Govt. of W.B., in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) dated 27.05.2019 read with Rule 33(2) of WBS (D.C.R.B.) Rules, 1971, for the purpose of pensionary benefit only.

However, the previous service of Sri Baru Das cannot be counted for seniority and MCAS'2001 benefit, for his present service, in West Bengal Engineering Services.

This has duly been approved by the Finance Department (Pension Cell) vide their **U.O. No. Pension/2023-2024/0190 dated 15.09.2023**.
