Memorandum

Sub: Implementation of RPL through DPMUs

1. RPL module will be implemented through DPMUs in Non - Project Mode.
2. RPL may be implemented in following categories.
 - a. RPL (Services)
 - b. RPL (Manufacturing)
 - c. RPL + Bridge (80 Hrs in total) (Services)
 - d. RPL + Bridge (80 Hrs in total)(Manufacturing)
3. Ceilings pertaining to RPL to be fixed by State HQ. The initial schedule is attached as annexure-I.
4. The implementation will be facilitated in both the Industry led and LOI based training modules.
5. Demand can be pooled at District level either directly by the DPMUs or with the support of the Line Departments/Training Providers already empanelled under PBSSD. The selection of TP and/or target assignment may be as decided by the DPMUs considering holistic scenario.
6. For the demand pooled by the line department, the selection of Training Providers and target assigning may be done by the District Level Committee comprising the following members:
 - i. District Magistrate/ ADM (Skills)- Chairman
 - ii. District Nodal Officer (Skills)- Member Secretary
 - iii. District TETSD Officer (Additional charge to Addl/ Jt Director Employment)
 - iii. Representative of the concerned line departments/or a nominee of the District magistrate.
- The committee may consider the following factors to determine suitability of the TP or for tie breaking while arriving their final decision w.r.t selection of TP(s) and target distribution.
 - a. Domain Compatibility
 - b. Readiness for executing the RPL module
 - c. Recent Performance
 - d. Administrative Convenience/ Choice of the Concerned Line Deptt
7. DPMUs shall adhere to the category wise ceilings prescribed for the district.
8. TPs who implemented the RPL module in the last RFP at State Level are given an option to get themselves registered under LOI sub-module. Interested TPs who fulfil this criterion may convey their interest by writing to the PBSSD HQ.
9. PASC authorized Head of the SPMU to take decision as regard the issues relating to the RPL through file processing and approval of the Head of the SPMU.
10. Demand of any line department which exceeds the quantum of 500 per annum/ per district (annual aggregated value) such cases to be referred to the PBSSD HQ for obtaining no objection.
11. The TPs shall adhere to the quality and standards of the training.
