Agenda: Proposal for recommendation of 07 (seven) new schemes (06 schemes costing below Rs 5.0 crore) for inclusion under Core SDS for FY of 2023-24

Secretary took the chair. The following were discussed;

- 1. One scheme (under sl 1) for de-siltation of Beliaghata Canal near Gajnabi Bridge to Chingrighata E.M. By-Pass within P.Ss Ultadanga, Maniktala, Narkeldanga, Beliaghata, Pragati Maidan, Dist- Kolkata under Executive Engineer-I, Canals Division initially technically recommended by the Departmental Committee of Chief Engineers in their 293rd Meeting held on 13.04.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work, scope of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for improvement of existing inspection road along right bank of Upper Bagjola Khal from Dum Dum Park Bridge Jessore Road Bridge Dum Dum Road Bridge within P.S-Lake Town, Dist- 24 Pgs (North) under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 82th Meeting held on 14.09.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- **3.** One scheme (under sl 3) for protection to the left bank of river Kalindri at Kirtitola, Block- Ratua-II, Dist- Malda under Executive Engineer, Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 80th Meeting held on 25.08.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- **4.** One scheme (under sl 4) for re-construction of one spur of Bibiganj-Jharsingheswar embankment along right bank of river Teesta in Block- Haldibari, Dist-Coochbehar under Executive Engineer ,Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 82th Meeting held on 14.09.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

5. One scheme (under sl 5) for improvement of one inspection path over New Cossye left Ex-Zmindari embankment within Panskura Municipality ,PS-Panskura, Dist-Purba Medinipur under Executive Engineer, East Midnapore Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 81st Meeting held on 01.09.2023 .This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

6. One scheme (under sl 6) for rehabilitation of 58 vent Ulughata Sluice in P.S.- Uluberia, Dist-Howrah under Executive Engineer, Metropolitan Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 76th Meeting held on 06.07.2023. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

7.One scheme (under sl 7) for construction of 02 (two) sluice gates over left bank of river Banka in P.S.Shaktigarh, Dist-Purba Burdwan under Executive Engineer-I ,Damodar Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 77th Meeting held on 20.07.2023 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet. It has been resolved that for this instant scheme separate tenders are to be invited by "Civil Wing" as well as "Mechanical Wing" of I.&W.Dte. having territorial jurisdiction, based on individual technically sanctioned amount within the provision of this scheme, for the interest of work.

8. One scheme for construction of two vent sluice at left bank of river Ganga in Raipur, Block-Budge Budge-II,Dist-South 24 Parganas under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 71th Meeting held on 25.05.23. This scheme was placed in the DSC meeting held on 26.06.2023 and it was resolved that "the scheme is to be resubmitted in next DSC meeting after checking by Central Design Office for additional scope of work as considered beyond provision in present drawing of CDO, furnishing requisite documents against required private land for implementation of this scheme ". Now the scheme has been resubmitted in present DSC meeting after due compliance of

Central Design Office part only and it has been resolved that again the scheme has to be resubmitted in next DSC meeting after furnishing requisite valid documents against required private land for implementation of this scheme.

9. One scheme for engagement of one Human Resources Provider for providing services of 02 nos. Draftsman in Central Design Office of I&WDte has been placed in the present DSC meeting and it has been resolved that the scheme may be booked under Administrative Expenditure subject to the Budget Provision of this Department.

10. Finally, 07 no. new schemes as per Annexure have been cleared by the DSC for inclusion under Core SDS during the current FY 2023-2024.

11.It has been directed to submit the soft copy (PDF version) of this scheme as per enclosed list duly technically sanctioned by the competent authority.


