Md. Shafiul Alam, Assistant Engineer (Civil), posted at Right Bank Irrigation Division in Irrigation & Waterways Department, was appointed as Technical Assistant Grade-II in Bengal Engineering & Science University, Shibpur presently IEST, Shibpur vide their memorandum no. RRS-4Offer/6771 dated 13.07.2006 on **27.07.2006 (FN)** in the Pay Scale of Rs. 4125-150-4575-175-5450-200-7450-225-9700/- as per WBS (ROPA) Rules, 1998.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Order No. 1077(32)-IE-8A-02/2012 dated 06.05.2013 of this Department, Md. Shafiul Alam joined the post of Assistant Engineer (Civil) in Irrigation & Waterways Department on **23.05.2013 (FN)** in the Pay Scale of Rs. 15600-42000 /- with Grade Pay of Rs. 5400/- as per ROPA 2009, after being released from the post of Technical Assistant Gr.-II on **22.05.2013 (AN)** vide Order No. 428 dated 22.05.2013 of the Registrar, BESU, Shibpur.

Now, the Governor has been pleased to accord approval to count the previous service from **27.07.2006 (FN) to 22.05.2013 (AN)**, as rendered by Md.
