**ORDER**

Sri Subhasis Bera, Executive Engineer (Civil), presently posted at Purulia Irrigation Division in Irrigation & Waterways Department, was appointed as Sub-Assistant Engineer (now renamed as Junior Engineer) in the o/o the Additional Chief Engineer (HQ) under Public works Directorate vide their order no. 1620-E dated 28.09.2000 on **16.10.2000 (FN)** in the Pay Scale of Rs. 4500-150-5250-175-7000-200-8800-225-9700 as per WBS (ROPA) Rules, 1998.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Notification No. 87 dated 21.08.2006 of this Department Sri Subhasis Bera joined the post of Assistant Engineer (Civil) in Irrigation & Waterways Directorate on **26.09.2006 (FN)** in the Pay Scale of Rs. 8000-275-13500 (PB-4A) as per WBS (ROPA) Rules, 1998; after being released from the post of Sub-Assistant Engineer on **25.09.2006 (AN)** vide Order No. 1129-E dated 14.09.2006 of the Additional Chief Engineer (HQ), Public Works Dte.

Now, the Governor has been pleased to accord approval to count the previous service from **16.10.2000 (FN) to 25.09.2006 (AN)**, as rendered by Sri Subhasis Bera, Executive Engineer (Civil), Purulia Irrigation Division, Irrigation & Waterways Directorate, in his erstwhile appointment to the post of Sub-Assistant Engineer (now renamed as Junior Engineer) in the o/o the Additional Chief Engineer (HQ) under Public works Directorate, Govt. of W.B., in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) dated 27.05.2019 read with Rule 33(2) of D.C.R.B. Rules' 1971, for the purpose of pension and leave only.

However, the previous service of Sri Subhasis Bera cannot be counted for seniority and MCAS benefit, for his present service, in West Bengal Engineering Services.

This has duly been approved by the Finance Department (Pension Cell) vide their **U.O. No. Pension/2023-2024/0310 dated 08.01.2024.**
