ORDER

In terms of Finance Department's Order No.8555-FDt.18.09.1985, the Governor has been pleased to allow the 1st higher scale of pay in the Pay Level-17 of Pay Range of Rs.67,300-1,73,200/- of Pay Matrix, WBS(ROPA)'2019 (pre-revised Band No.4A of Band Pay Scale of Rs.15,600-42,000/- with Grade Pay of Rs.6,600/- as per WBS (ROPA) Rules, 2009), for completion of more than 6 (Six) years continuous and satisfactory service in favour of **Shri Shibaprasad Roy, Ex-Assistant Engineer (Civil)**, presently posted as **Executive Engineer (Civil) & TA to Superintending Engineer, North Irrigation Circle-II**, Irrigation & Waterways Directorate; w. e. f. 20.02.2016; until further order.
