Agenda: Proposal for recommendation of 10 (ten) new schemes (10 schemes costing below Rs 5.0 crore) for inclusion under Core SDS for FY of 2023-24

One scheme (under sl 1) for construction of two (02) RCC bridges over drainage channels near 02 CD Structures of Kopai South Main Canal within Block Bolpur-Sriniketan Dist- Birbhum under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 85th Meeting held on 02.11.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
2. One scheme (under sl 2) for construction of three (03) RCC bridges over drainage channels near 02 CD Structures of Kopai South Main Canal within Block Bolpur-Sriniketan Dist- Birbhum under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 85th Meeting held on 02.11.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
3. One scheme (under sl 3) for protection work along right bank of river Fulhar at Ramayanpur and Ruhimari within Block- Ratua-I Dist-Malda under Executive Engineer, Mahananda Embankment Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 88th Meeting held on 01.12.2023.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
4. One scheme (under sl 4) for improvement of Ex-Zamindari embankment along left bank of river Ajoy at Tikuri , Block-Nanoor, Dist-Birbhum under Executive Engineer, Mayurakshi South Canal Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 38th Meeting held on 30.05.2022.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
5. One scheme (under sl 5) for improvement of Ex-Zamindari embankment along left bank of river Ajoy at Sundarpur , Block-Nanoor, Dist-Birbhum under Executive

Engineer, Mayurakshi South Canal Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 41th Meeting held on 30.06.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

6. One scheme (under sl 6) for construction of one RCC Bridge over Kalma khal at Radhanagar , Block- Nakashipara , Dist- Nadia under Executive Engineer, Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 48th Meeting held on 14.09.2022. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

7. One scheme (under sl 7) for rehabilitation of Gopia Sluice, Tarapur Sluice, Aluipara Sluice at Hijuli , Block- Shantipur , Dist-Nadia under Executive Engineer, Nadia Irrigation Divn and Metropolitan M & E Divn initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 79th Meeting held on 16.08.2023 .. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet. It has been resolved that for this instant scheme separate tenders are to be invited by “Civil Wing“ as well as “Mechanical Wing” of I.&W.Dte. having territorial jurisdiction, based on individual technically sanctioned amount within the provision of this scheme, for the interest of work.

8. One scheme (under sl 8) for protection work along right bank of river Rasulpur with strengthening of right side marginal embankment at Uttar Dihimukundapur ,Block- Deshpran ,Dist- Purba Medinipur [Ref : **Sorasori Mukhyamantri**] under Executive Engineer, Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 84th Meeting held on 16.10.2023 .. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

9. One scheme (under sl 9) for improvement of Santal Colony Irrigation Scheme over river Turturi , GP- Samuktala , Block- Alipurduar-II, Dist- Alipurduar under Executive Engineer, Alipurduar Irrigation Division initially technically recommended by the

Directorate Level Technical Committee of I.&W.Dte. in their 90th Meeting held on 14.12.2023 ..This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.



One scheme protection work along right bank of river Ghargharia at Chaudanga area, Block- Coochbehar-II ,Dist- Coochbehar under Executive Engineer, Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 91th Meeting held on 22.12.2023 .This scheme has been placed in the present DSC meeting and it has been resolved that the scheme is to be withheld due to wanting of some requisite documents.

12. One scheme protection work along right bank of river Baniadaha at Ghughumari area, Block- Dinhata-I ,Dist- Coochbehar under Executive Engineer, Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 90th Meeting held on 14.12.2023 .This scheme has been placed in the present DSC meeting and it has been resolved that the scheme is to be withheld due to wanting of some requisite documents..

13. Finally, 10 nos. new schemes as per Annexure have been cleared by the DSC for inclusion under **Core SDS** during the current **FY 2023-2024**.


