

This scheme has been re-submitted in the present DSC meeting after due compliance of RoD of the DSC meeting held on 15.01.2024 and recommended with some modification in name of work and some attachment within scheme booklet.[Ref : SSM]

One scheme (under sl 13) for replacement of manual hoisting system by Electro-Mechanical hoisting system of outfall sluice at Ichapur khal , Block & PS-Barrackpore, Dist- 24 Pgs(North) under Executive Engineer, Metropolitan M&E Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 93th Meeting held on 05.01.2024. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.


