One scheme (under sl 16) for rehabilitation of right guide bundh at upstream of Teesta Barrage in Block- Rajganj, PS-Bhorer Alo ,Dist- Jalpaguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 96th Meeting held on 30.01.2024 followed by Departmental Technical Committee of Chief Engineers in their 322 Meeting held on 02.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
