Agenda: Proposal for recommendation of 12 (twelve) new schemes (11 no. schemes costing below Rs 5.0 erore) for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2023-24

One scheme (under sl 1) for de-siltation of Naldari khal within GP-Burul, Block-Budge Budge-II, PS- Nodakhali, Dist- 24 Pgs(South) under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 94<sup>th</sup> Meeting held on 16.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for rehabilitation of 07 nos RCC bridges at different places over Kata khal, Hobka khal, Suryapur inner channel, Sangrampur khal within Block-Mograhat-II, PS- Mograhat and one 32 vent sluice cum bridge over river Peali within Block & PS- Kultali, Dist- 24 Pgs (South) under Mograhat Drainage Division initially technically recommended by the Directorate Level Technical Committee in their 52th Meeting held on 21.10.2022. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for construction of boundary wall at Dhosa stack-yard and at Uttarbagh bungtow campus within Block & PS- Baruipur ,Dist-24Pgs(South) under Megrahat Drainage Division initially technically recommended by the Directorate Level Technical Committee in their 82<sup>th</sup> Meeting held on 14.09.2023. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme (under sl 4) for protection work to retaining wall along left bank of river Hooghly at Jyoti Basu Uddan near Budge Budge Club within Ward No. 2 of Budge Budge Municipality, PS- Budge Budge, Dist- 24 Pga(South) under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 94th Meeting held on 16.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 5. One scheme (under sl 5) for protection work along left bank of river Hooghly between Charial thans ghat to Orient ghat within Ward No. 4 of Budge Budge Municipality, PSBudge Budge, Dist- 24 Pga(South) under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 94th Meeting held on 16.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme (under sl 6) for de-siltation along with protection work of Padma Nallah within Habra, Ashoknagar-Kalyangarh Municipality within Block- Habra-I, PS- Habra, Dist-24Pgs(North) under Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee in their 87th Meeting held on 24.11.2023. This scheme has been placed in DSC meeting held on 11.12.2023 and it was resolved that the scheme is to be resubmitted in next DSC meeting after checking by the Central Design Office for additional scope of work related to slope protection against slip which may occur during de-siltation. Accordingly this scheme has been reframed, placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for improvement of inspection path over Keliaghai Right embankment at Taladiha within GP- Amarshi-II, Block- Patashpur, PS- Dist- Purba Medinipur [Ref: SSM] under Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 96th Meeting held on 30.01.2024. This scheme has been placed in present DSC meeting and recommended with some medification in name of work and some attachment within scheme booklet.
- 8. One scheme (under sl 8) for construction of one foot bridge over upper Bhehula drainage channel at Khetput-Durmushegar, GP- Bakulia Dhobapara, Block & PS-Balagarh, Dist-Hooghly [Ref: Paray Samadhan] under Executive Engineer-I, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 84th Meeting held on 10.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 9. One scheme ( under sl 9 ) for construction of one foot bridge over upper Bhehula drainage channel at Atkatial. GP- Baidyapur ,Block-Kalna-II ,PS- Kalna , Dist-Purba Bardhaman [Ref: Paray Samadham ] under Executive Engineer-I, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 84th Meeting held on 10.01.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 10. One scheme ( under sl 10 ) for construction of one foot bridge over upper Bhehula drainage channel at Dutta Dariaton , GP- Anukhal, Block-Kalna-II, PS- Kalna , Dist-Purba Bardhaman [Ref: Paray Samadhan ] under Executive Engineer-I, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 84<sup>th</sup> Meeting held on 10.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme hooklet.
- 11. One scheme (under st 11) for improvement of Dakshin Changmari Premganj embankment along left bank of river Teesta, within Block -Kranti and PS- Mal Bazar, Dist- Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 95<sup>th</sup> Meeting held on 22.01.2024 followed by Departmental Technical Committee of Chief Engineers in their 323 Meeting held on 07.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme (under sl 12) for bank protection work along both bank of river Dhardhara, within GP- Paharpur, Block -Sadar and PS-Kotwali. Dist-Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 97<sup>th</sup> Meeting held on 09.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
