Annual enhancement on 01.07.2024 shall be allowed after such revision to all such contractual workers **excepting** those who have been engaged after 01.01.2024 or has completed 5/10/15/20 years of engagement after 01.01.2024.

All other existing conditions of engagement shall remain unchanged.

Overdrawn amount, if any, incurred due to erroneous fixation in due course or in future, may be recovered forthwith from the monthly Remuneration of the said contractual workers.
