One scheme (under sl 1) for construction of one single lane RCC Bridge at Purirabad over S.A.M.D. Part-I Channel within G.P.- Bagampur, Block & PS- Baruipur, Dist- 24 Pgs (.South) under Executive Engineer, Metropolitan Drainage Division-II initially technically recommended by the Directorate Level Technical Committee in their 101<sup>th</sup> Meeting held on 12.03.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for construction of boundary wall and extension of civil office building including remodeling of old pump house at Uttarbhag Pumping Station campus within Block and PS Baruipur ,Dist- 24 Pgs(South) under Executive Engineer, Metropolitan Drainage Division-II initially technically recommended by the Directorate Level Technical Committee in their 101<sup>th</sup> Meeting held on 12.03.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

Bridge over Guguria khal within GP- Muragacha, Block and PS- Nakashipara, Dist-Nadia under Executive Engineer, Nadia Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 100<sup>th</sup> Meeting held on 01.03.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
  - 5. One scheme (under sl 5) for rehabilitation of Tilpara Barrage by protection of downstream apron, upstream guide bundh and other ancillary works within Block-Suri-I, PS- Suri, Dist- Birbhum under Executive Engineer, Mayurakshi Head Quarters Division initially technically recommended by the Directorate Level Technical Committee in their

- 93<sup>rd</sup> Meeting held on 03.01.2024 followed by Departmental Technical Committee of Chief Engineers in their 326 Meeting held on 18.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme (under sl 6) for construction of one R.C.C. foot Bridge over upper Behula Channel at village Dighirpur, within GP- Bhalukia-Dhobapara, Block and PS- Balagarh ,Dist-Hooghly [ Ref- Paray Samadhan ] under Executive Engineer-I, Lower Damodar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 97<sup>th</sup> Meeting held on 09.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for protection work along right bank of river Nonai at Purba Duramari within Block & PS-Dhupguri, Dist-Jalpaiguri [Ref-Sorasori Mukhyomantri] under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 99<sup>th</sup> Meeting held on 22.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 8. One scheme (under sl 8) for construction of embankment along right bank of river Jayanti at Panbari, within G.P. Turturi, Block—Alipurduar-II, PS-Shamuktala, Dist-Alipurduar, under Executive Engineer, Alipurduar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 99<sup>th</sup> Meeting held on 22.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 9. One scheme (under sl 9) for strengthening of protection work along left bank of river Teesta adjacent to outfall of Kaya channel within G.Ps Podamoti I, Podamoti- II, Block and PS- Maynaguri, Dist- Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 101<sup>th</sup> Meeting held on 12.03.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 10. One scheme (under sl 10) for protection work along right bank of river Karala at Paresh Mitra colony and Shantipara within Ward No. 25 of Jalpaiguri Municipality, PS-Kotwali, Dist-Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 103<sup>th</sup> Meeting held on 19.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 11. One scheme (under sl 11) for construction of internal boundary wall around main administrative building & laboratory building of Haringhata Central Laboratory of River Research Institute at Mohanpur within Block & PS- Harighata, Dist- Nadia under Executive Engineer, Sundarban Delta Project initially technically recommended by the Directorate Level Technical Committee in their 106<sup>th</sup> Meeting held on 17.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme for strengthening of Sundarban embankment at Gobardhanpur facing Bay of Bengal in Block- Pratharprotima, P.S- Gobardhanpur Coastal, Dist- 24 Pgs (South) under Executive Engineer, Kakdwip Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 100<sup>th</sup> Meeting held on 01.03.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is dropped at present due to technical reasons, as requested by the Chief Engineer (South), I&WDte also communicated vide No. 1922-CI dated 11<sup>th</sup> June 2024.
- 13. One scheme for protection work along right bank of river Danga khari out falling to river Atrai at A.K.Gopalan Colony within Block and PS- Balurghat, Dist- Dakshin Dinajpur under Executive Engineer, South Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 97<sup>th</sup> Meeting held on 09.02.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted in next DSC meeting after reviewing scope of works in due consultation with the Central Design Office, I&WDte.

- 14. Finally, 11 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
- 15. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
