Record of discussion of the meeting chaired by the Joint Secretary, Irrigation & Waterways Department, Government of West Bengal on 07.06.2024 at Jalasampad Bhawan with the officials of Bharat Sanchar Nigam Limited and Irrigation & Waterways Directorate, to review the status of installation of FTTH line at different offices of I & WD in Kolkata Telephone (KT) area and West Bengal Telecom Circle (WBTC) area

At the outset, the Joint Secretary, Irrigation & Waterways Department briefly stated the difficulties being faced by different offices of I & WD particularly in dealing with e-offices, OPMS, IFMS and related IT platforms, due to low speed of installed internet connections of BSNL. He also emphasised on the urgency of immediate implementation of the balance connection as per latest MOU. The Sr. General Manager, BSNL, intimated the present status of connections both in KT area and WBTC area and also about name of Nodal Officers from the BSNL end. After detailed discussions, the following decisions were taken:

### A. Available Internet Speed at the user end:

i. It was informed by the BSNL officials that for checking the available internet speed at user end a joint field verification is to be done primarily at Jalasampad Bhavan between the representatives from BSNL and representatives of Metropolitan Electrical Division preferably within next week. (Action: BSNL)

ii. For balance connection in KT area and WBTC area the FTTH connection speed may be checked case to case basis, depending upon the specific complain raised by the respect user. (Action: I & WD and BSNL)

### B. Latest Status of FTTH connection both in KT area and WBTC area

- i. The BSNL officials informed that in KT area out of 100 nos. connections,98 nos connections have already been completed and the rest 2 nos. connections will be completed by 20/06/2024. (Action: BSNL)
- ii. The BSNL officials informed that in WBTC area out of 177 nos. connections,164 nos connections have already been installed & completed and the rest 11 nos. connections will be completed by 20/06/2024. But two nos connection one at Pullah Road and another at Itamogra. will take some time due to cable laying problem, but BSNL will try their best to complete the same at earliest. (Action: BSNL)
- iii. For balance connections Irrigation & Waterways Department will send a proposal to BSNL and upon receiving the proposal BSNL authority will take action accordingly.

  (Action: BSNL & I & WD)

# C. Name & Designation of Nodal Officer on behalf of BSNL

The BSNL officials informed that Mr. Bishal Gourav, ADM, FTTH, S&M, KTD (Mob. No.94320 01554) will act as a Nodal Officer of KT area and Smt. Maitrayee Bagchi JTO, (Mob no.94349 00111) will act as a Nodal Officer of WBTC area. Henceforth, all sorts of official communication will be made by the EE, DVC Study Cell (Nodal Officer of I & WD) with the abovementioned Officers according to their respective jurisdiction. (Action: BSNL & I & WD)

Irrigation & Waterways Department raises the issues of cases running against this Department in Lok Adalat filed by BSNL authority. The BSNL officials said they will look into the matter.
