Sub : Directives regarding 'Length Ceiling' & Cost Ceiling of 'AMC of Drainage Channels'.

Ref. : Memo. No. 1951-CI, dated 18.06.2024 from Office of the Chief Engineer – South,
Irrigation & Waterways Directorate, Government of West Bengal.

In continuation of this Department's earlier order in connection with 'AMC of Drainage Channels' issued vide Order No. 197(4)-IW-14011(99)/24/2022, dated 09.05.2024, the undersigned is further directed to clarify the term 'Length Ceiling' and it should cover the following : -

- i) Minimum length (as mentioned in the order dated 09.05.2024) of designated drainage channel for which AMC has to be taken up and no reduction in length will be entertained.
- ii) If any savings will located after tendering as per sl - (i) above, maximum '+5%' of length ceiling could be taken up additionally without crossing the cost ceiling.
- iii) If tendering as per sl - (i) above attracts additional cost beyond the cost ceiling, a detail proposal will require to be submitted to this Department for enhancement of cost ceiling.

Henceforth 'Length Ceiling' always denotes the above nomenclature.

2. All other contents of the earlier Order No. 197(4)-IW-14011(99)/24/2022, dated 09.05.2024 are remain unchanged.
