Records of Discussion of the meeting of the “**Departmental Screening Committee**” for screening of RIDF-XXX schemes held at Jalasampad Bhavan, Salt Lake on 12th July, 2024 at 12.00 PM

The concerned Superintending Engineers & Executive Engineers also remained present through VC.

Agenda: Proposal for recommendation of 8 (Eight) new schemes for posing under “**RIDF-XXX**” for Irrigation & Waterways Department.

Secretary took the chair. At the onset of the meeting, the Secretary, I&WD, asked all concerned Executive Engineers to follow guidelines of RIDF scheme preparation and mention name of Village, Gram Panchayet and Block in the name of scheme. He advised to submit technically vetted DPRs to NABARD for sanction. He requested Superintending Engineer, Investigation & Planning Circle-I to check all DPRs following the guideline before submission to NABARD. The scheme wise discussions and the findings of the DSC are as follows:

1. ‘Protection work for a length of 500.00m (Reach-I) and for a length of 500.00m (Reach-

- II), Total length of 1000.00m along the left bank of river Sui (Sooiin) at Kachua and behind of NTBK High Madrasha under G.P.-Marnai in Block & P.S.-Itahar, District-Uttar Dinajpur' (under Sl.1) under Executive Engineer, North Dinajpur Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 105th meeting held on 06.05.2024 and Departmental Technical Committee of Chief Engineers in their 327th meeting held on 22.05.2024, has been placed in the present DSC meeting and recommended with suggestion to insert typical cross-section sheet for the proposed work in the DPR.
2. 'Protection work to the left bank for 800 M length at Vill-Doba Haspukur and to the right bank for 350 M length at Village-Haspukur of river Haria in Block & P.S.-Bamongola, District-Malda' (under Sl.2) under Executive Engineer, Malda Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 108th meeting held on 14.06.2024, has been placed in the present DSC meeting and recommended with suggestion to show pre-work and post-work level in cross-section sheets in the DPR and rectify Benefit-Cost ration of the scheme.
 3. 'Anti erosion work on left bank of river Bhagirathi for a length of 2000.00 m at Dadupur, Mouza-Udaychandrapur, in Block & P.S.-Nakashipara, District-Nadia' (under Sl.3) under Executive Engineer, Nadia Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 106th meeting held on 17.05.2024, has been placed in the present DSC meeting and recommended with suggestion to insert typical cross-section sheet and rectify cross-section sheets as well for the proposed work in the DPR.
 4. 'Bank Protection work to the Left Bank of River Bhagirathi at Hot Nagar for a length of 700 M (i.e. from 408.70 Km to 408.00 Km) in P.S. & Block- Berhampore, District-Murshidabad' (under Sl.4) under Executive Engineer, Berhampore Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 104th meeting held on 26.04.2024, has been placed in the present DSC meeting and recommended.
 5. 'Mahananda Main Canal Lining work using Bituminous Geo Membrane (B.G.M) from Chainage 15.00 km to Chainage 15.70 km of MMC under Mahananda Canal Division in Block & P.S.-Phansidewa, District-Darjeeling' (under Sl.5) under Executive Engineer, Mahananda Canal Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 79th meeting held on 16.08.2023 and Departmental Technical Committee of Chief Engineers in their 317th meeting held on 12.09.2023, has been placed

in the present DSC meeting and recommended with suggestion to specify rate of GST in the abstract of the scheme.

6. 'Remodeling of embankment along left bank of River Ichamati for a length of 600 m near Itinda Bazar, Itinda Madrasa and old Shamshan at Mouza-Itinda & Panitore in Block-Basirhat-I, P.S.-Basirhat, District-North 24 Parganas' (under Sl.6) under Executive Engineer, Basirhat Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 107th meeting held on 30.05.2024, has been placed in the present DSC meeting and recommended.
7. 'Replacement of 14 nos spillway gates with its allied parts including painting of trestle bridge of Durgapur Barrage on Damodar River at Block & P.S.- Barjora, District - Bankura' (under Sl.7) under Executive Engineer, Durgapur M&E Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 105th meeting held on 06.05.2024 and Departmental Technical Committee of Chief Engineers in their 328th meeting held on 18.06.2024, has been placed in the present DSC meeting and recommended with suggestion of incorporation of compliance report of DLTC under signature of Chief Engineer and rectify Benefit-Cost ration of the scheme.
8. 'Protection to the eroded left bank of river Darakeswar for a total length of 1000.00 Mtr. at Purba Thakuranichak in Block- Khanakul – I, P.S –Khanakul, District – Hooghly' (under Sl.8) under Executive Engineer-I, Lower Damodar Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 108th meeting held on 14.06.2024, has been placed in the present DSC meeting and recommended with suggestion to insert typical cross-section sheet for the proposed work in the DPR and to specify rate of GST in the abstract of the scheme. Rate analysis sheets approved by the Superintending Engineer are also to be inserted in the DPR.

It has been directed to submit soft copy (PDF version) of DPR of all 8 (Eight) recommended schemes as stated above, after incorporation of the minor changes as suggested in the DSC meeting, to the Superintending Engineer, Investigation & Planning Circle-I, I&W Dte for checking and onward submission to NABARD through the Chief Engineer(South), I&W Dte.




