The concerned Superintending Engineers & Executive Engineers also remained present through VC.

Agenda: Proposal for recommendation of 6 (Six) new schemes for posing under "RIDF-XXX" for Irrigation & Waterways Department.

Secretary took the chair. At the onset of the meeting, the Secretary, I&WD, asked all concerned Executive Engineers to strictly follow the guidelines of RIDF scheme preparation and mention name of Village, Gram Panchayet and Block in the name of scheme. He advised to page mark the DPR before submission to NABARD. He again advised to submit technically vetted DPRs to NABARD for sanction instead of technically sanctioned one. He requested Superintending

Engineer, Investigation & Planning Circle-I to check all DPRs following the guideline before submission to NABARD. The scheme wise discussions and the findings of the DSC are as follows:

- 1. 'Construction of Sluice cum Road Bridge over Gurepole Khal at Pansrapara near outfall on right bank of river Hooghly in G.P.-Baneswarpur-I, Block-Shyampur-I, P.S.-Shyampur, District-Howrah' (under Sl.1) under Executive Engineer-II, Lower Damodar Construction Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 110th meeting held on 16.07.2024, was placed in the present DSC meeting and recommended with suggestion to correct cross-section sheets and drawing of cross bundh for the proposed work in the DPR.
- 2. 'Protection work along the left bank of Rupnarayan river for a length of 1140.00 M between Poltaberia Burning Ghat & Benia in G.P.-D Mondal Ghat-I, Block-Shyampur-II, P.S.-Shyampur, District-Howrah' (under Sl.2) under Executive Engineer-II, Lower Damodar Construction Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 110th meeting held on 16.07.2024, was placed in the present DSC meeting and recommended.
- 3. 'Protection work along Right Bank of Hooghly river and confluence portion of Damodar river for a length of 450.00 M near Zilla Parishad Jetty in Block-Shyampur-I, P.S.-Shyampur, District-Howrah' (under Sl.3) under Executive Engineer-II, Lower Damodar Construction Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 110th meeting held on 16.07.2024, was placed in the present DSC meeting and recommended with suggestion for minor modification in the name of the scheme as 'Protection work along Right Bank of Hooghly river and left and right bank of Damodar river for a the length of 450.00 M near the confluence point of Damodar river with Hooghly river in Block-Shyampur-I, P.S.-Shyampur, District-Howrah'.
- 4. 'Protection to the Rup-Right Schedule-D embankment in between Betalbasan Ashram & Donipur Bazar for a length 760 m and in between Bar Amritberia Ferry Ghat & Amritberia Sluice for a length of 690 m in Mouzas Betalbasan, Totaberia, Ichhapur, Mirpur, Bar Amritberia & Amritberia Block& P.S. Nandakumar & Mahisadal, District Purba Medinipur' (under Sl.4) under Executive Engineer, East Midnapore Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 109th meeting held on 04.07.2024, was placed in the present DSC meeting and recommended.
- 5. 'Bank protection work to the Right Bank of river Tangon (350 m) at u/s of Mohammadpur Primary School, G.P.- Salaidanga & Left Bank of river Mahananda (350 m) at

Rajaramchak, G.P.- Alal for a total length of 700 M in Block & P.S. - Gazole, District - Malda' (under Sl.5) under Executive Engineer, Malda Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 109th meeting held on 04.07.2024, was placed in the present DSC meeting and recommended with a suggestion to correct the Benefit-Cost ratio of the scheme, include Index map with proper marks and to insert typical cross-section of the proposed work.

6. 'Remodeling of Sundarban Embankment along the Right Bank of river Raimangal for a length of 775 m at Monsatal at Mouza - Monipur in Block - Sandeshkhali - II, P.S. - Sandeshkhali, District - North 24 Parganas' (under Sl.6) under Executive Engineer, Basirhat Irrigation Division, technically recommended by the Directorate Level Technical Committee (DLTC) in their 110th meeting held on 16.07.2024, was placed in the present DSC meeting and recommended with suggestion to correct drawings.

It has been directed to submit soft copy (PDF version) of DPR of all 6 (Six) recommended schemes as stated above, after incorporation of the minor changes as suggested in the DSC meeting, to the Superintending Engineer, Investigation & Planning Circle-I, I&W Dte for checking and onward submission to NABARD through the Chief Engineer(South), I&W Dte.
