ORDER

Sri Hirak Sett, Assistant Engineer (Civil), Central Design Office in Irrigation & Waterways Department, was appointed as Sub-Assistant Engineer (now renamed as Junior Engineer) under Water Resources Development Directorate vide order no. 3853(85)/6R-1/02-03 dated 31.03.2003 of the Director of Personnel & Ex-Officio Chief Engineer, WRD Dte. and hence joined as Sub-Assistant Engineer on **05.05.2003 (A.N.)**.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of Notification No. 93 dated 21.02.2013 of this Department, Sri Hirak Sett joined the post of Assistant Engineer (Civil) in Irrigation & Waterways Directorate on **26.03.2013 (F.N.)**; after being released from the post of Sub-Assistant Engineer on **25.03.2013 (A.N.)** vide Order No. 2757/1(13)-3E/X/3/2010(pt.-I) dated 25.03.2013 of the Additional Director of Agriculture (Admn.) in pursuance of memo no. 2542/3E-3(T) Part-I/11 dated 19.03.2013 of the Director of Personnel & Ex-Officio Chief Engineer, WRD Dte.

Now, the Governor has been pleased to accord approval to count the previous service from **05.05.2003 (A.N.) to 25.03.2013 (A.N.)**, as rendered by Sri Hirak Sett, Assistant Engineer (Civil), Central Design Office, Irrigation & Waterways Directorate, in his erstwhile appointment to the post of Sub-Assistant Engineer (now renamed as Junior Engineer) under Water Resources Development Directorate, Govt. of W.B., in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) dated 27.05.2019 read with Rule-22 read with Rule 33(2) of D.C.R.B. Rules'1971, for the purpose of pensionary benefits only.

However, the previous service of Sri Hirak Sett cannot be counted for seniority and MCAS benefit, for his present service, in West Bengal Engineering Services.
