One scheme (under sl 1) for re-construction of ex-zamindary right embankment of river Kuye within GP- Hizole, Block & PS-Kandi, Dist- Murshidabad [ Ref-Sorasori Mukhyomantri] under Executive Engineer, Mayurakshi South Canals Division initially technically recommended by the Directorate Level Technical Committee in their 99<sup>th</sup> Meeting held on 22.02.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for re-sectioning of two irrigation canals under Mayurakshi Reservoir Project i.e Dy-7 of DBMC and Dy-1 of DBBC within Block-Rampurhat-I, PS Rampurhat, Dist-Birbhum [ Ref-Sorasori Mukhyomantri ] under Executive Engineer, Mayurakshi North Canals Division initially technically recommended by the Directorate Level Technical Committee in their 99<sup>th</sup> Meeting held on 22.02.2024. One scheme ( under sl 9 ) for construction of embankment along right bank of river Muriganga within mouza- Bankimnagar , Block and PS Sagar , Dist- 24 Pgs( South) under Executive Engineer, Kakdwip Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 71<sup>th</sup> Meeting held on 25.05.2023 followed by Departmental Technical Committee of Chief Engineers in their 326 Meeting held on 18.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 10. One scheme for improvement of inspection path along right side of LBMC at Dayalpur, Ura within Block-Galsi-II, PS -Galsi, Dist-Purba Burdwan [ Ref-Sorasori Mukhyomantri ] under Executive Engineer-I, Damodar Canals Division initially technically recommended by the Directorate Level Technical Committee in their 96<sup>th</sup> Meeting held on 30.01.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted with some modifications for next DSC meeting.
- 11. One scheme for improvement of inspection path along Damodar left embankment at Dumur within Block-Galsi-II, PS -Galsi, Dist-Purba Burdwan [ Ref-Sorasori Mukhyomantri ] under Executive Engineer-I, Damodar Canals Division initially technically recommended by the Directorate Level Technical Committee in their 96<sup>th</sup> Meeting held on 30.01.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted with some modifications for next DSC meeting.
- 12. One scheme for replacement of damaged flap shutters, draw shutters including hoisting arrangement of Talkanpur sluice, Chakghuli (South) sluice, Hamirpur Sluice, Chakghuli (North) sluice, Mania sluice, Jagmohanchawak sluice within Block- Ramnagar-I, Ramnagar-II, PS- Ramnagar, Dist- Purba Medinipur under Executive Engineer, Mechanical & Electrical Division, Midnapore initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted after incorporating necessary civil works by Contai Irrigation Division for next DSC meeting.
