Agenda: Proposal for recommendation of 06 (Six) new schemes (04 schemes costing below Rs 5.0 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2024-25

Secretary took the chair. The following were discussed;

- 1. One scheme (under sl 1) for reconstruction of embankment facing river Jagaddal at Sitarampur ,within Block- Patharprotima, P.S- Gobardhanpur Coastal, Dist- South 24 Parganas under Executive Engineer, Kakdwip Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024 followed by Departmental Technical Committee of Chief Engineers in their 327th Meeting held on 22.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for reconstruction of embankment along right bank of river Chenargang at Baliara, within Block-Namkhana, P.S- Frezarganj Coastal, Dist- South 24 Parganas under Executive Engineer, Kakdwip Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024 followed by Departmental Technical Committee of Chief Engineers in their 327th Meeting held on 22.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for protection work along right bank of Western Channel at Dinesh pally within Ward No. 114 of KMC, P.S.- Regent Park, Dist- Kolkata under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 106th Meeting held on 17.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme (under sl 4) for construction of ring bundh along country side of left embankment of river Hooghly at Dariratneswarpur within Block and PS- Kulpi Dist-South 24 parganas under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 105th Meeting held on 06.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 5. One scheme (under sl 5) for protection work at downstream of low height weir on river Atreyee within Block and PS- Balurghat, Dist.- Dakshin Dinajpur under Executive Engineer, South Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 109th Meeting held on 04.07.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme (under sl 6) for improvement of inspection path on Damodar Left embankment at Dumur within Block- Galsi- II, PS- Galsi, Dist- Purba Bardhaman [Ref-Sorasori Mukhyomantri] under Executive Engineer-I, Damodar Canals Division initially technically recommended by the Directorate Level Technical Committee in their 96th Meeting held on 30.01.2024. This scheme was placed in DSC Meeting held on 21.05.2024 and it was resolved that the scheme is to be resubmitted in next DSC meeting with some modification., Accordingly the scheme is resubmitted in present DSC meeting with due compliance and recommended with some modification in name of work and some attachment within scheme booklet
- 7. One scheme for improvement of inspection path on right embankment of Buxi khal from Jardai to Kalidan within Block and PS- Panskura, Dist- Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, East Midnapur Division, initially technically recommended by the Directorate Level Technical Committee in their 98th Meeting held on 16.02.2024. This scheme was placed in DSC Meeting held on 23.02.2024 and it was resolved that the scheme is to be resubmitted in next DSC meeting after reviewing scope of work in consultation with the Central Design Office. Accordingly the scheme is resubmitted in present DSC meeting with due compliance and it has been resolved that the scheme is to be resubmitted in next DSC meeting after reviewing the specification of work in consultation with the Central Design Office.
- 8. One scheme for Maintenance and Repair to the left bank of river Fulhar from Sankaritola to Dhormotola within G.P- Mathurapur, Block and PS- Manikchak, Dist- Malda [Ref-Sorasori Mukhyomantri] under Executive Engineer, Malda Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 99th Meeting held on 22.02.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be booked under SDS Maintenance fund, considering nature of work.

- 9. Finally, 06 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
- 10. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
