One scheme (under sl 1) for resuscitation of Dunia khal within G.P.- Kulberia, Block and PS -Chandipur, Dist- Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 103th Meeting held on 19.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for protection work along right bank of river Ghargharia at Chaudanga within Block- Coochbehar-II, PS- Pundibari, Dist-Coochbehar [Ref-Sorasori Mukhyomantri] under Executive Engineer, Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 91th Meeting held on 22.12.2023. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for protection work along right bank of river Baniadaha at Ghughumari within Block-Dinhata-I, PS- Dinhata, Dist-Coochbehar under Executive Engineer, Coochbehar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 90th Meeting held on 14.12.2023. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme (under sl 4) for SITC of gates, hoisting arrangement of cross regulator gate at Ch. 256.50 of MBMC at Fatepur within Block- Suri-I, PS. Suri, Dist- Birbhum under Executive Engineer, Mayurakshi Electrical & Mechanical Division initially technically recommended by the Directorate Level Technical Committee in their 105th Meeting held on 06.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet
- 5. One scheme (under sl 5) for SITC of gates, hoisting arrangement of cross regulator gate at Ch. 520.00 of MBMC at Bhurkuna within Block- Suri-I, PS. Suri, Dist- Birbhum under Executive Engineer, Mayurakshi Electrical & Mechanical Division initially technically recommended by the Directorate Level Technical Committee in their 105th Meeting held on 06.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet

- 6. One scheme for resuscitation of Chhatri khal within Block –Egra-I, PS –Egra, Dist- Purba Medinipur [Ref–Sorasori Mukhyomantri] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 103th Meeting held on 19.04.2024. This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted in next DSC meeting after reviewing scope of works in due consultation with the Central Design Office, I&WDte.
- 7. Finally, 05 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
- 8. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
