Agenda: Proposal for recommendation of 09 (Nine) new schemes (All schemes costing below Rs 5.0 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2024-25

Secretary took the chair. The following were discussed;

- 1. One scheme (under sl 1) for construction of fencing at both banks of Circular Canal near Galif Street within Ward Nos 5,6,7 of KMC, PSs Shyampukur and Chitpur, Dist-Kolkata under Executive Engineer-I, Canals Division, initially technically recommended by the Directorate Level Technical Committee in their 108th Meeting held on 14.06.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for reconstruction of embankment along left bank of river Kantakhali at Ghosalati within Block and PS-Hasnabad, Dist-North 24 Pgs facing under Executive Engineer, Basirhat Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 109th Meeting held on 04.07.2024 followed by Departmental Technical Committee of Chief Engineers in their This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet. It has been further resolved that during final submission of DPR to accord AAFSGO, detailed land schedule, RoR and consent of all affected land owners, to hand over required land to the Government for the interest of this instant work, are to be attached within the technically sanctioned DPR. Besides, it should also be explored whether there is any vested land exits within the proposed embankment alignment.
- 3. One scheme (under sl 3) for protection work along right bank of Danga khari out falling to river Atrai at A.K.Gopalon Colony within P.S. and Block- Balurghat, Dist- Dakshin Dinajpur under Executive Engineer, South Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 97th Meeting held on 09.02.2024. This scheme was placed in DSC Meeting held on 13.06.2024 and it was resolved that the scheme is to be resubmitted in next DSC meeting after reviewing scope of works in due consultation with the Central Design Office, I&WDte. Accordingly the scheme is resubmitted in present DSC meeting with due compliance and recommended with some modification in name of work and some attachment within scheme booklet

- 4. One scheme for resuscitation of Bahichberia khal within Blocks and PSs –Nandakumar and Tamluk, Dist- Purba Medinipur [Ref–Sorasori Mukhyomantri] under Executive Engineer, East Medinipur Division, initially technically recommended by the Directorate Level Technical Committee in their 109th Meeting held on 04.07.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 5. One scheme (under sl 5) for resuscitation of Balisai branch khal within G.P.s-Vivekananda and Deshbandhu, Block –Egra-II, PS –Egra, Dist- Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 102th Meeting held on 08.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme (under sl 6) for resuscitation of Fulbari khal within G.P.- Amtalia , Block Desopran, PS-Contai , Dist- Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 106th Meeting held on 17.05.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for resuscitation of Dakshin Kulanjhara khal within G.P.-Aurai, Block-Desopran, PS-Contai ,Dist- Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 106th Meeting held on 17.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 8. One scheme (under sl 8) for resuscitation of Tripurakhali khal within Block and PS-Nandakumar, Dist-Purba Medinipur [Ref-Sorasori Mukhyomantri] under Executive Engineer, East Midnapore Division, initially technically recommended by the Directorate Level Technical Committee in their 109th Meeting held on 04.07.24. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

9. One scheme (under sl 9) for replacement of damaged flap shutters, draw shutters including hoisting arrangement of Talkanpur sluice, Chakghuli (South) sluice, Hamirpur Sluice, Chakghuli (North) sluice, Mania sluice, Jagmohanchawak sluice within Block-Ramnagar-I, Ramnagar-II, PS-Ramnagar, Dist- Purba Medinipur, under Executive Engineer, Mechanical & Electrical Division, Midnapore and Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024. This scheme was placed in DSC Meeting held on 21.05.2024 and it was resolved that the scheme is to be re-submitted after incorporating necessary civil works in next DSC meeting. Accordingly the scheme is resubmitted in present DSC meeting with due compliance and recommended with some modification in name of work and some attachment within scheme booklet. It has been resolved that for this instant scheme separate tenders are to be invited by "Civil Wing" as well as "Mechanical Wing" of I&WDte. having territorial jurisdiction, based on individual technical sanctioned amount within the provision of this scheme, for the interest of work

10. Finally, 09 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.

11. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
