Agenda: Proposal for recommendation of 11 (Eleven) new schemes (All schemes costing below Rs 5.0 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of **2024-25**  Secretary took the chair. The following were discussed ;

- One scheme ( under sl 1 ) for construction of one single lane R.C.C. Bridge over Keorapukur khal at Ch. 18.50 km at Bahiuddin within G.P- Mohanpur ,Block-Mograhat-II ,P.S-Mograhat, Dist-South 24 Parganas under Executive Engineer-II, Canals Division, initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for construction of one single lane R.C.C. Bridge over Natunbazar khal near Pallymangal Samity within Ward No. 112 of Kolkata Municipal Corporation ,P.S-Bansdroni, Dist-South 24 Parganas under Executive Engineer-II, Canals Division, initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme ( under sl 3 ) for re-sectioning of Charial Main khal within Ward No.- 143, 144 of Kolkata Municipal Corporation, P.S-Thakurpukur, Dist- South 24 Parganas under Executive Engineer, Suburban Drainage Division initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme (under sl 4) for construction of one single lane RCC Box Bridge over EE-I khal at Kada within Block and PS- Rajarhat, Dist- North 24 Parganas under Executive Engineer, Metropolitan Drainage Division-I initially technically recommended by the Directorate Level Technical Committee in their 109<sup>th</sup> Meeting held on 04.07.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 5. One scheme ((under sl 5) for resuscitation of Taltala Gopalnagar khal from Natun hat to Taltala PWD Bridge within Blocks-Joynagar-I & II, P.S-Jaynagar, Dist-South 24 Parganas under Executive Engineer, Mograhat Drainage Division, initially technically recommended by the Directorate Level Technical Committee in their 109<sup>th</sup> Meeting held on 04.07.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 6. One scheme (under sl 6) for renovation of Office of the D.P.&Ex-Officio Chief Engineer, I&WDte. at 4<sup>th</sup> Floor of Western Block of Jalasampad Bhawan, Salt Lake , PS-Bidhannagar, Dist- Kolkata under Executive Engineer, Metropolitan Drainage Division-I, initially technically recommended by the Directorate Level Technical Committee in their 107<sup>th</sup> Meeting held on 30.05.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for resuscitation of Chhatri khal within Block-Egra-I, P.S-Egra, Dist-Purba Medinipur [ Ref-Sorasori Mukhyomantri ] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 103<sup>th</sup> Meeting held on 19.04.2024. This scheme was placed in DSC meeting held on 19.07.2024 and it was resolved that the scheme is to be resubmitted in next DSC meeting after reviewing scope of works in due consultation with the Central Design Office, I&WDte. Accordingly this scheme was reviewed by the Central Design Office and placed in present DSC meeting. This scheme has been recommended with some modification in name of work, attachment of compliance report w.r.t observations of Central Design Office and some others within scheme booklet.
- 8. One scheme (under sl 8) for reconstruction of Bhadul Surpanagar Causeway over River Darakeswar within Block and PS-Onda, Dist-Bankura [Ref-Sorasori Mukhyomantri] under Executive Engineer, Bankura Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 99<sup>th</sup> Meeting held on 02.04.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 9. One scheme (under sl 9) for resuscitation of Jhauboni Branch Khal from Keorapukur Sluice to Mondal Para Culvert and from Kharipukuria Sluice to outfall point at Odisha Coastal Channel within Block –Contai-III and PS-Contai, Dist-Purba Mednipur [ Ref-Sorasori Mukhyomantri ] under Executive Engineer, Contai Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 114<sup>th</sup> Meeting held on 28.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme (under sl 10) for protection work along left bank of Gundakhaya Jhora at Chhota Noapara within Ward No. 43 of Siliguri Municipal Corporation, PS-Bhaktinagar, Dist- Jalpaiguri [ Ref-Sorasori Mukhyomantri ] under Executive Engineer, Siliguri Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 11. One scheme (under sl 11) for protection work along left bank of river Bataria adjacent to Naxalbari Market Area within Block and PS-Naxalbari, Dist-Darjeeling [ Ref-Sorasori Mukhyomantri ] under Executive Engineer, Siliguri Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme for protection work along left bank of river Hooghly in front of bunglow of Commissioner of Police within Ward No. 21, Barrackpore Municipality, PS-Barrackpore, Dist- 24 Pgs (North) under Executive Engineer-I, Canals Division, initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024 .This scheme has been placed in present DSC meeting and it has been resolved that the scheme is to be re-submitted in next DSC meeting after reviewing scope of works in due consultation with the Central Design Office, I&WDte.
