Dakshin Chandipur, Block and PS- Manikchak, Dist.- Malda under Executive Engineer, Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 121th Meeting held on 04.12.2024.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme (under sl 2) for Rehabilitation of Tilpara Barrage by reconstruction of downstream flexible floor, apron, left flare wall including sand grouting below downstream impervious floor within Block-Suri-I, P.S- Suri, Dist- Birbhum under Executive Engineer, Mayurakshi Head Quarters Division initially technically recommended by the Departmental Technical Committee of Chief Engineers in their 337th Meeting held on 16.12.2024.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
