Agenda: Proposal for recommendation of 09 (five) new schemes ( 07 schemes costing below Rs 5.0 crore) for inclusion under **Core SDS** for FY of **2024-25**

Secretary took the chair. The following were discussed;

1. One scheme (under sl 1) for reconstruction of embankment along left bank of river Gomor at Mouza Dayapur, within Block- Gosaba , PS- Sundarban Coastal, Dist- South 24 Parganas under Executive Engineer-I, Joynagar Irrigation Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 113<sup>th</sup> Meeting held on 13.08.2024. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

2. One scheme (under sl 2) for construction of ring bundh including inspection path by connecting Bhutnidiara Circuit Embankment to left bank of river Ganga from Paschim Ratanpur to Srimantola within Blocks- Manikchak, Ratua-I Dist-Malda under Executive Engineer, Malda Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 114<sup>th</sup> Meeting held on 28.08.2024 followed by Departmental Technical Committee of Chief Engineers in their 331<sup>st</sup> Meeting held on 13.09.2024 . This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

3. One scheme (under sl 3) for renovation of wearing coat on deck slab of Teesta Barrage at Gajoldoba within Blocks –Rajganj , Mal , District-Jalpaiguri under Executive Engineer, Teesta Barrage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 120<sup>th</sup> Meeting held on 27.11.2024. This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

4. One scheme (under sl 4) for supply, installation, testing and commissioning of of four nos. 50 cusec (each) Vertical Turbine Pump set with allied electrical (HT & LT) and mechanical works for Dum Dum Park Pumping Station at confluence point of Cantonment khal and Bagjola khal within PS- Baguiati , Dist- North 24 Parganas under Executive Engineer, Metropolitan Drainage Mechanical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 116<sup>th</sup> Meeting held on 20.09.2024 followed by Departmental Technical Committee of Chief Engineers in their 333<sup>rd</sup> Meeting held on 29.10.2024 . This scheme has been placed in the present DSC



meeting and recommended with some modification in name of work and some attachment within scheme booklet.

5. One scheme (under sl 5) for replacement of Flap shutters , Draw shutters , Hoisting systems of Bhurkunda sluice and Jagatpur sluice within Blocks- Basirhat-I ,II ,Kholapota ,Dist: North 24 Parganas under Executive Engineer, Metropolitan Mechanical & Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 115<sup>th</sup> Meeting held on 09.09.2024 .This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

6. One scheme (under sl 6) for improvement of Keyatala Sluice cum Bridge over Suryapur Inner Channel within Block and P.S- Baruipur, Dist- South 24 Parganas. under Executive Engineer, Metropolitan Drainage Mechanical Division and Mograhat Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 115<sup>th</sup> Meeting held on 09.09.2024 .This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

It has been resolved that for this instant scheme separate tenders are to be invited by the “Civil Wing” as well as “Mechanical Wing” of I&WDte. having territorial jurisdiction, based on individual technical sanctioned amount within the provision of this scheme, for the interest of work

7. One scheme (under sl 7) for Renovation of electrical illumination system at Banipur Rest Shed compound and allied works within Ward No. 21 of Habra Municipality , P.S- Habra , Dist- North 24 Parganas under Executive Engineer, Metropolitan Mechanical & Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 73<sup>th</sup> Meeting held on 08.06.2023 .This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

8. One scheme (under sl 8) for renovation of electrical illumination system at Keyatala Sluice , Dhosa Sluice , Hobka Sluice , Suryapur stackyard , Dhosa Rest Shed, Joynagar

One scheme (under sl 9) for Supply installation testing and commissioning of six nos air conditioning machines , IT related points and allied works including renovation of electrical illumination system at Establishment Section of Irrigation and Waterways Department at 1st Floor South Block, Jalsampad Bhawan, Salt Lake City within P.S.- Bidhannagae, Dist- Kolkata under Executive Engineer, Metropolitan Electrical Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 117<sup>th</sup> Meeting held on 30.09.2024 .This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.


