One scheme (under sl 1) for protection work along left embankment of river Hooghly at Mallickpara-Nainan, Block-Diamond Harbour-II, P.S Ramnagar, Dist-South 24 Pgs. under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 126<sup>th</sup> Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
2. One scheme ( under sl 2 ) for protection work along left bank of river Hooghly near Taragaung, at Bishra within Block- Diamond Harbour-II, P.S.- Ramnagar, Dist –South 24 Pgs under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 127<sup>th</sup> Meeting held on 10.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
3. One scheme ( under sl 3 ) protection work along left embankment of river Hooghly at Kabipara-Nainan , Block-Diamond Harbour-II, P.S Ramnagar, Dist-South 24 Pgs. under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 126<sup>th</sup> Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

Basti ghat, Ramjanoki Ghat) within Ward no. 141 of KMC and Ward no. 7 of Maheshtala Municipality, P.Ss-Nadial , Rabindranagar, Dist-South 24 Pgs. under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 followed by Departmental Technical Committee of Chief Engineers in their 339 Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.



5. One scheme ( under sl 5 ) for protection work along right bank of outfall channel into river Hooghly near Kanchantala Sashan Kali Temple within Ward no 140 of Kolkata Municipal Corporation, P.S. Nadial, Dist-Kolkata. under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 126<sup>th</sup> Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
6. One scheme ( under sl 6 ) for de-siltation of Management khal from outfall point at Churial Main Khal within Ward no. 144 of KMC to Daulatpur within Block Bishnupur – I ,P.S. – Thakurpukur, Dist – South 24 Pgs under Executive Engineer , Suburban Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
7. One scheme ( under sl 7) for de-siltation of Mayapur khal in within Block- Budge Budge-I, PS - Budge BudgE, Dist – South 24 Pgs. under Executive Engineer , Suburban Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
8. One scheme (under sl 8) for de-siltation of Balarampur branch khal of Kantakhali main khal within Block and P.S. - Falta, Dist – South 24 Pgs. under Executive Engineer , Suburban Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme (under sl 9) for de-Siltation of Godakhali khal from Rania Bazar to Godakhali Sluice and its branch khal from Nodakhali more to Godakhali khal within Block-Budge Budge-II ,P.S-Nodakhali, Dist-South 24 Pgs. under Executive Engineer , Suburban Division initially technically recommended by the Directorate Level Technical

10. One scheme (under sl 10) for protection work along left bank of river Sui at Chottobella within G.P.- Gulander-II , Block and P.S.- Itahar, Dist.- Uttar Dinajpur. ( **Ref : SSM** ) under Executive Engineer, North Dinajpur Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 124<sup>th</sup> Meeting held on 31.12.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
11. One scheme (under sl 11) for protection work along right bank of river Panchanoi at right bank near Salbari krishi farm ( length 200 M ) , Mahabert high school ( length 600 M ) , and along left bank adjacent to PMGYS road ( length 500 M ) , near Dagapur Tea factory ( length 400 M) for a total length of 1700 M within Block-Matigara P.S- Pradhan Nagar , Dist. Darjeeling.( **Ref : SSM**) under Executive Engineer, Siliguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 124<sup>th</sup> Meeting held on 31.12.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
12. One scheme (under sl 12) for special repair work with boulder replenishment to damaged boulder pitching and providing additional protective measures to coastal protection structure in between Ch. 12.0 km to Ch. 14.745 km at within G.P.-Talgachari-II, Block-Ramnagar-I , PS- Ramnagar , Dist. Purbam Medinipur.under Executive Engineer,Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 122<sup>th</sup> Meeting held on 12.12.2024 followed by Departmental Technical Committee of Chief Engineers in their 339 Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet




