Agenda: Proposal for recommendation of 16 (Sixteen) new schemes (15 schemes costing below Rs 5.0 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of **2024-25**  Secretary took the chair. - One scheme (under sl 1) for protection work along left embankment of river Hoogly from Achipur Dakghar to Achipur Chenamontala within Block- Budge Budge-I, P.S-Pujali, District-South 24 Pgs under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 123<sup>th</sup> Meeting held on 20.12.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for protection work along left bank of river Hooghly adjacent to Tara Maa Ghat within Ward No.7 of Maheshtala Municipality, P.S-Rabindranagar, Dist-South 24 Pgs. under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 124<sup>th</sup> Meeting held on 31.12.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme ( under sl 3 ) for protection work along left embankment of river Hoogly at Pujali Palpara ( length 400 M) and adjacent to Achipur Launch Ghat ( length 100 M ) within Block- Budge Budge-I , P.S-Pujali, District-South 24 Pgs under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 4. One scheme ( under sl 4 ) for improvement of Kellar Math adjacent to left embankment of river Hoogly within Ward No. 9 under Diamond Harbour Municipality, P.S-Diamond Harbour, Dist.-South 24 Pgs under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 5. One scheme ( under sl 5 ) for de-Siltation of Raichak khal from Raichak Sluice to Paschim Gobindapur within Block-Diamond Harbour- II, P.S- Ramnagar, Dist-South 24

Pgs .under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 6. One scheme ( under sl 6 ) for de-Siltation of Bhabanipur Khal from Bhabanipur Sluice to Karaiberia within Block-Diamond Harbour- II, P.S- Ramnagar, Dist-South 24 Pgs under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 125<sup>th</sup> Meeting held on 03.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme ( under sl 7) for de-siltation of river Jamuna from Tipi to d/s of Charghat RCC bridge within Block and PS. Swarupnagar, Dist.-North 24 Pgs under Executive Engineer, Bidyadhari Drainage Division initially technically recommended by the Directorate Level Technical Committee in their 119<sup>th</sup> Meeting held on 21.11.2024 followed by Departmental Technical Committee of Chief Engineers in their 336 Meeting held on 05.12.2024. This scheme as a whole has been placed in present DSC meeting and recommended inprincipally with some modification in name of work and some attachment within scheme booklet. It has been resolved that de-siltation work [ Part –A ] of this scheme may be taken up from North 24 pgs District Authority as No Cost Basis from Govt. Exchequer . Allied protection work [ Part B ] may be taken up by the concerned Executive Engineer of this Department. As both the works to be executed simultaneously at field, AAFS GO against Part B is to be generated after according approval of Part A from the appropriate authority.
- 8. One scheme (under sl 8) for protection work along left bank of river Ganga from Ch. 23.500 km to Ch. 25.200 km u/s of Farakka Barrage at Gopalpur within Block and P.S Manikchak, Dist.-Malda. under Executive Engineer, Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 121<sup>th</sup> Meeting held on 04.12.2024 followed by Departmental Technical Committee of Chief Engineers in their 338 Meeting held on 30.12.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
