At present, the DPRs of the purely State Funded Projects having value of Rs. 5 Crore and above are examined and recommended for accordance of Administrative Approval through 'Departmental Screening Committee (DSC)', by the 'Departmental Technical Committee of Chief Engineers (DTCCE)' vide this Department's Memo No. 396-IB/IW/O/IB-Misc-51/2019-20 dated-24.12.2019. The schemes of value of Rs. 5 Crore and above are recommended by the 'Directorate Level Technical Committee (DLTC)' and sent to the 'Departmental Technical Committee of Chief Engineers (DTCCE)' for conducting 2nd tier checking to ensure their technical and economic viability.

- 2. Since there is overlap in the members between the DLTC and the DTCCE, it has been felt necessary to discontinue the 'Departmental Technical Committee of Chief Engineers (DTCCE)' for effective and optimum utilization of available technical manpower. So, henceforth all the DPRs of the purely State Funded Projects of any value will be examined and recommended for accordance of Administrative Approval through 'Departmental Screening Committee (DSC)', by the 'Directorate Level Technical Committee (DLTC)'.
- **3.** In view of the above, the 'Departmental Technical Committee of Chief Engineers (DTCCE)' is being discontinued until further order and this order will take immediate effect.
