Sub: 'Pre-monsoon Allocation for 2025-26' out of Maintenance Budget under State Development Scheme of 2025-26.

After careful consideration of the proposal furnished by him, the undersigned is directed to convey the in-principle approval towards Pre-monsoon Allocation of ₹ 150.00 Crore (Rupees One Hundred Fifty Crore) only for the Financial Year 2025-26. The same is to be borne out of SDS Maintenance Budget of F.Y. 2025-26, subordinate to Demand No. 32 as contained in BP-18.

- 2. The purpose of instant Pre-monsoon Allocation of 2025-26 as follows:
 - (a) Procurement and stacking of Flood Fighting Materials (FFM) at stretegic locations like bamboo, bullah, sand bags, earth, sand, temporary pumps etc.
 - (b) Operation and Maintenance (O&M) of various sluice gates, regulators, inlets associated with flood management.

- (c) Minor repair to damaged flood embankments, river banks, drainage channels, irrigation canals like rain cuts, ghoghs, slip, subsidence etc.
- (d) Repair of pumps and their accessories.
- Directorate-wise Pre-Monsoon allocation for 2025-26 is given below: 3.

- He is requested to submit the Division Specific Ceiling Amount restricted 4. within the 'Total Ceiling amount' as shown above through mail to bivabasu.iwd@rediffmail.com within 15.03.2025, so that 'Ceiling Limit in OPMS' against individual Divisions could be placed accordingly by this Department for generation and submission of DPRs through OPMS by him. The requisite ceiling will be shown in OPMS on and from 1st April, 2025.
- Necessary Pre-monsoon works of 2025-26 as stated under para. 2 above, only 5. is to be tendered immediately following normal tender norms and existing rules and regulations. He is further requested to take necessary steps so that Work Orders to the successful tenderers should be issued before March, 2025.

It is further advised that necessary activities like mobilization of work etc. may be initiated as soon as possible so that the entire works should be completed as per the timeline laid down in the SOP issued vide No. 07-W/2023-24 dated 12/06/2023.

- 6. The expenditure to be booked under SDS (Maintenance) during 2025-26. Post facto Administrative Approval through AAFS will be accorded on Tendered Amount plus contingency subject to availability of sufficient commitment (phasing) in AAFS module and release of fund also depends on availability of maintenance fund with this Department during 2025-26.
- 7. DPRs are required to be submitted through 'Flood SDS (M)' Menu of OPMS only by 31st May, 2025.
- 8. Superintending Engineers & Executive Engineers concerned are to be informed accordingly.
- 9. This is issued with the approval of the Additional Chief Secretary of this Department.
