**ORDER**

Sri Abhijit Kumar Das, Senior Work's Man, Teesta Mechanical Division, Irrigation & Waterways Directorate has prayed for voluntary Retirement from service on personal ground on attaining more than 20 years of service.

Thus, in terms of Rule No. 75 (aaa) of WBSR Part-I read with memorandum no. 6620-F dated 20.08.1981 of Finance (Audit) Department, Sri Abhijit Kumar Das, Senior Work's Man, Teesta Mechanical Division, Irrigation & Waterways Directorate, has been allowed to retire voluntarily on the ground of unavoidable personal compulsion.

The minimum age criteria for voluntary retirement of Sri Das has been relaxed as per memorandum no. 454- F(P) dated 01.02.2021 of Finance (Audit) Department.

Overdrawal, if any, arising out of extra ordinary leave, erroneous pay fixation etc. and any other dues to the Government, incurred by Sri Das and duly sanctioned in favour of him, should forthwithly be realized from retiring gratuity etc., as entitled to Sri Das by his Pension Sanctioning Authority, in due course.
