ORDER

Sri Somenath Chakraborty was appointed to the post of Sub-Assistant Engineer (Civil) (now renamed as Junior Engineer) in Irrigation & Waterways Department on 30/12/2010(F.N.) at basic pay of **Rs. 13,400/-** in the Pay Band-4 (Rs. 9,000-40,500/-) with Grade Pay of Rs. 4,400/- as per WBS(ROPA) Rules, 2009 in pursuance of the Order No. 3803(87)-CIE dated-28/12/2010 of the Director of Personnel & Ex-Officio Chief Engineer, Irrigation & Waterways Directorate.

Before joining the post of SAE(Civil) in Irrigation & Waterways Directorate, Sri Somenath Chakraborty had joined the post of 'Nirman Sahayak' on 23/05/2006(F.N.) under the Department of Panchayat & Rural Development vide Order No. 762/P&RD dated 22/05/2006 of Executive Officer, Bankura Zilla Parishad in the Pay Scale of Rs. 9,000/- - 40,500/- with Grade pay of Rs. 4,400/- as per ROPA 2009 with Basic pay of **Rs. 13,400/-** as per WBS(ROPA) Rules 2009. His last basic pay in the post of 'Nirman Sahayak' was **Rs. 14,660/-** in PB-4 in the pay scale of Rs. 9,000-40,500/- with Grade Pay of Rs. 4,400/- as per WBS (ROPA) Rules, 2009.

Now, in terms of rule 42A (5) of W.B.S.R., Part-I, Sri Somenath Chakraborty, Junior Engineer(Civil), Irrigation and Waterways Directorate is hereby allowed to draw basic pay at **Rs. 14,660/-** including Grade Pay of Rs. 4,400/- in PB-4 of Rs. 9,000-40,500/- under the WBS(ROPA) Rules, 2009 w.e.f. **30/12/2010(F.N.)**, allowing next increment with effect from **01/07/2011**. However, while counting service length towards Revised MCAS benefit, his previous service will not be taken into account.
