**ORDER**

**Sri Sujit Seal**, Junior Engineer (Civil), under Irrigation & Waterways Department, presently posted under Canals Division, Irrigation & Waterways Directorate, was appointed as **Work-Charged Work-Assistant** under Public Works Department on **15/02/1993(F.N.)** vide Memo No. 133/1(4) dated **12/02/1993** of Superintending Engineer, (P.W.D.), Metropolitan Sports Circle in the scale of pay of Rs. 1040-1920/- of WBS (ROPA) Rules 1990.

Having been selected in the Sub-Assistant Engineer (Civil) Recruitment Examination conducted by PSC, WB and in pursuance of **Memo No. 1962(68)-CIE dated- 27/06/2011** of Director of Personnel & Ex-Officio Chief Engineer, Irrigation and Waterways Directorate, Sri Sujit Seal joined in the post of Sub-Assistant Engineer (Civil) in Irrigation & Waterways Department on **24/08/2011(F.N.)** in the Pay Band of Rs. 9,000 – 40,500/- (PB-4) with Grade Pay Rs. 4,400/- of WBS (ROPA) Rules 2009, after being released on **23/08/2011 (A.N.)** by the Assistant Engineer, South Suburban Sub-Division-II, Public Works Department vide **Memo No. 295/1(3) dated 23/08/2011**.

Now, the Governor has been pleased to accord the approval regarding counting of past service during the period from **15/02/1993(F.N.) to 23/08/2011(A.N.)** service rendered as Work-Charged Work-Assistant under Public Works Department in favour of Sri Sujit Seal, Sub-Assistant Engineer(Civil) now renamed as Junior Engineer(Civil) under Irrigation & Waterways Directorate for pensionary benefits only along with his present service since 24/08/2011, in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) Dated: 27/05/2019 read with Rule 33(2) of D.C.R.B. Rules' 1971.

However, the erstwhile service of Sri Sujit Seal cannot be counted for seniority and MCAS benefit, for his present service, in West Bengal Engineering Services.
