The Irrigation & Waterways Department has taken a holistic approach by constituting a Central Tender Unit [CTU] vide Memorandum No. 28-W/2024-25 dt 21<sup>st</sup> February 2025 with subsequent corrigendum Order 03-W/2025-26 dt 12.04.2025. One of the objective to constitute this Central Tender Unit is to prepare Bid Documents for Dredging Works by adopting “No Cost to State Exchequer” policy and to invite Bids. A letter of this Department has already been issued to the Chief Engineer [ Design & Research ] I.&W.Dte. ,vide No. 240-IB , dt 15.05.2025 ,to float bid for dredging work by adopting “No Cost to State Exchequer” policy ,based on draft bid document ,as prepared by CTU and submitted by the CE (D&R) to this Department vide No. 654-CI, dt 16.04.2025

2.Irrigation & Waterways Department has already been entrusted to carry out dredging adopting on “**Volume Sharing**” basis in terms of Memo No. MDTC/SAND/002/646 dated 01.04.2022 of WBMDTCL, based on the approved bid documents of WBMTDCL .



3 In view of above, it has been decided within this Department that other working Circles may also invite bid for dredging with volume sharing method of "No Cost to State Exchequer" policy, adopting the tender document approved by this Department for use by CTU for the same purpose vide Memo No. 240-IB dt 15.05.2025 with suitable modifications with regard to designation of concerned Chief Engineer, Superintending Engineer, Executive Engineer and Divisional Accounts Officer, as applicable, but without any material deviation. However the Chief Engineer (Design & Research), I&WDte. will remain a member of the bid evaluation committee apart from the concerned Chief Engineer.

4. Accordingly the consent of this Department is being conveyed to adopt the bid document sent vide memo under ref to invite bid for dredging with volume sharing method of "No Cost to State Exchequer" policy. The power of acceptance of H1 bid will be as per tender acceptance power, delegated as per FD Memo No. 2320-F(Y) dated 07.06.2022, based on estimated value / project value of the dredging works.


