ORDER

Sri Joyanta Das was appointed to the post of Sub-Assistant Engineer (Civil) (now renamed as Junior Engineer) in Irrigation & Waterways Department on **25/01/2011(F.N.)** at basic pay of **Rs.13,400 /-** in the Pay Band-4 (Rs. 9,000-40,500/-) with Grade Pay of Rs. 4,400/- as per WBS(ROPA) Rules, 2009 in pursuance of the Order No. 3803(87)-CIE dated-28/12/2010 of the Director of Personnel & Ex-Officio Chief Engineer, Irrigation & Waterways Directorate.

Before joining the post of Sub-Assistant Engineer (Civil) in Irrigation & Waterways Directorate, Sri Joyanta Das had joined the post of '**Nirman Sahayak**' under the Department of Panchayat & Rural Development at Paduma Gram Panchayat under Dubrajpur Block, Dubrajpur, District- Birbhum on **14/06/2007(F.N.)** vide Memo No. 10142(41)/P dated 12/06/2007 of Executive Officer, Birbhum Zilla Parishad & District Magistrate, Birbhum in the Pay Scale of Rs. 4500/- - 9700/- of WBS(ROPA) Rules 1998 with Basic pay of Rs.4500 /-. His last basic pay in the post of 'Nirman Sahayak' was **Rs. 14,660/-** in PB-4 in the pay scale of Rs. 9,000-40,500/- with Grade Pay of Rs. 4,400/- as per WBS (ROPA) Rules, 2009.

Now, in terms of rule 42A (5) of W.B.S.R., Part-I, Governor has been pleased to allow Sri Joyanta Das, Junior Engineer (Civil), Mayurakshi Head Quarters Division under Irrigation & Waterways Directorate, to draw **Rs. 14,660/-** (Pay in Pay Band-4 Rs. 10,260/- + Grade Pay Rs. 4400/-) in Pay Band No. - 4 of Rs. 9000-40500/- with Grade Pay Rs. 4400/- **with effect from 25/01/2011** by way of protection of his last pay drawn in his past service as Nirman Sahayak under PRI set up of this Government. His next annual increment would fall due on 01/07/2012, if he is eligible otherwise.

Benefits under MCAS/Revised CAS shall only be admissible to Sri Das from his date of joining in the present service i.e. from 25/01/2011.
