ORDER

Sri Saikat Sarkar, presently posted as Assistant Engineer (Civil) under Urban Drainage Division, Irrigation & Waterways Directorate, was appointed as Sub-Assistant Engineer (Civil) under Water Resources Development Directorate on **14/07/2004(F.N.)** vide Memo No. 6500(110)/6R-1/04 Dated 13/07/2004 of the Directorate of Personnel & Ex-Officio Chief Engineer, Water Resources Development Directorate, Government of West Bengal in the scale of pay of Rs. 4500-9700/- of WBS (ROPA) Rules 1998.

Having been selected in the Assistant Engineer (Civil) Recruitment Examination, 2015 conducted by PSC, WB and in pursuance of Notification No. 74 Dated 13/10/2017 of Joint Secretary to the Government of West Bengal, Irrigation & Waterways Department, Sri Saikat Sarkar joined the post of Assistant Engineer (Civil) in Irrigation & Waterways Department on **01/12/2017(F.N.)** in the Pay Band No. PB-4A of the Scale of Pay of Rs. 15600 - 42000/- with Grade Pay Rs. 5400/-, after being released from the post of Sub-Assistant Engineer (Civil) on **30/11/2017(A.N.)** vide Memo No. 190(7) Dated-30/11/2017 of the Assistant Engineer (A-I), Berhampore (Agri-Irrigation) I&P Sub-Division, Berhampore: Murshidabad.

Now, the Governor has been pleased to accord approval regarding counting of past service in favour of Sri Saikat Sarkar, presently officiating in the post of Assistant Engineer (Civil) for rendering service as Sub-Assistant Engineer (Civil) under Water Resources Development Directorate for the period **from 14/07/2004 to 30/11/2017** along with his present service since 01/12/2017 for pensionary benefit only subject to make entry of service verification in Service Book since 01/07/2024 in respect of present service, in terms of Finance (Pension) Department's Memorandum No 249-F (Pen) Dated: 27/05/2019 read with Rule 33(2) of D.C.R.B. Rules' 1971.

However, the previous service of Sri Saikat Sarkar cannot be counted for seniority and MCAS benefit, for his present service, in West Bengal Engineering Services.
