## ORDER

Sri Debasis Das was appointed to the post of Sub-Assistant Engineer (Civil) (now renamed as Junior Engineer) in Irrigation & Waterways Department on 13/07/2011(F.N.) at basic pay of Rs.13,400 /- in the Pay Band-4 (Rs. 9,000-40,500/-) with Grade Pay of Rs. 4,400/- as per WBS(ROPA) Rules, 2009 in pursuance of the Order No. 1962(68)-CIE dated-27/06/2011 of the Director of Personnel & Ex-Officio Chief Engineer, Irrigation & Waterways Directorate.

Before joining the post of Sub-Assistant Engineer (Civil) in Irrigation & Waterways Directorate, Sri Debasis Das was appointed as **Nirman Sahayak** at Malibari-I Gram Panchayat on contract basis through usual norms on 31/12/2004(F.N.) vide Memo No. 1462/1(5) dated 30/11/2004.
