
In reference to the above mentioned letter the undersigned has been directed to say that it has been decided after discussion with the competent authority to prefer an appeal before the Hon'ble Division Bench of Calcutta High Court challenging the validity of the judgment and order dated 11.12.2025 passed by Hon'ble Justice Krishna Rao of the said Court. Further communication in this regard will be made to you in due course.

It is further pertinent to note that the concerned Tender Inviting Authority, after due deliberation in this regard has decided not to proceed with the concerned tender process which you have mentioned in your letter dated 12.12.2025, until the issue is finally addressed through legal process and thus the said tender process may now be treated as cancelled. Hence you request regarding inclusion of your name in the TBO as 'qualified' by amending the said TBO, has now lost its purpose and therefore cannot be acceded to.

In regard to the requests regarding removal of your name from the list of Debarred Contractors as maintained in the Department's website, it may be informed you that the concerned authority has already been instructed for this purpose, subject to the condition that such withdrawal of

debarment shall be abide by the decision of the appropriate court of law, and the same will duly be uploaded in the Department's website at the earliest.




